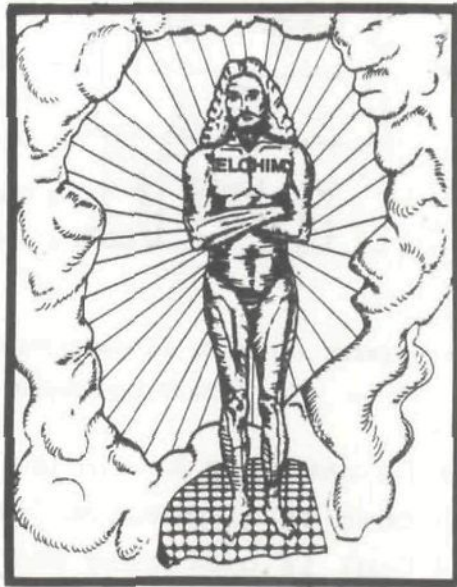

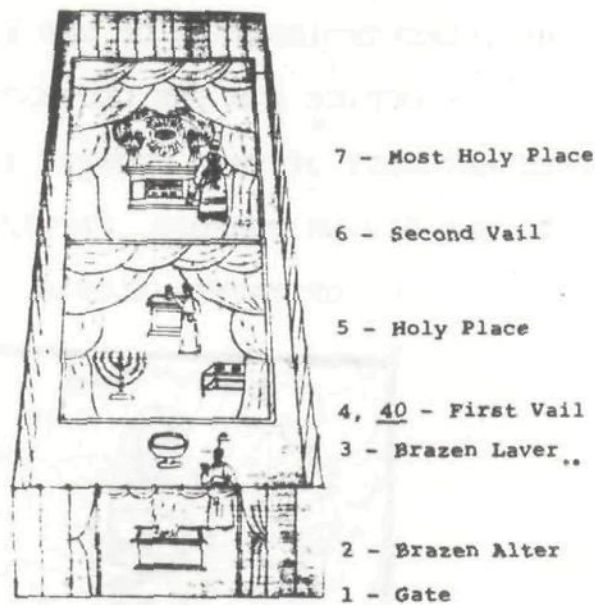

NOTE TO THE READER - BASIC PSYCHOLOGICAL PREPARATION

All events in the Past, Present and Future were Fore-known and Predestinated (Isa. 46:9-10) by Yahweh-Elohim (Lord-God) of this Stellar Universe, and unerringly carried out in accordance to the Design (Structure) and the Operation (Function) of the High Priest performing his daily and yearly duties in the Divine Tabernacle Pattern. This Mosaic Tabernacle Pattern is an explanation of the Spiritual Tabernacle or Yahweh-Elohim's (Lord God's) Spiritual Embodiment (see Cover) that Moses saw in a vision atop Mt. Sinai. like the one he saw atop Mt. Sinai (Ex. 25:8-9, 40; Heb. 8:5).

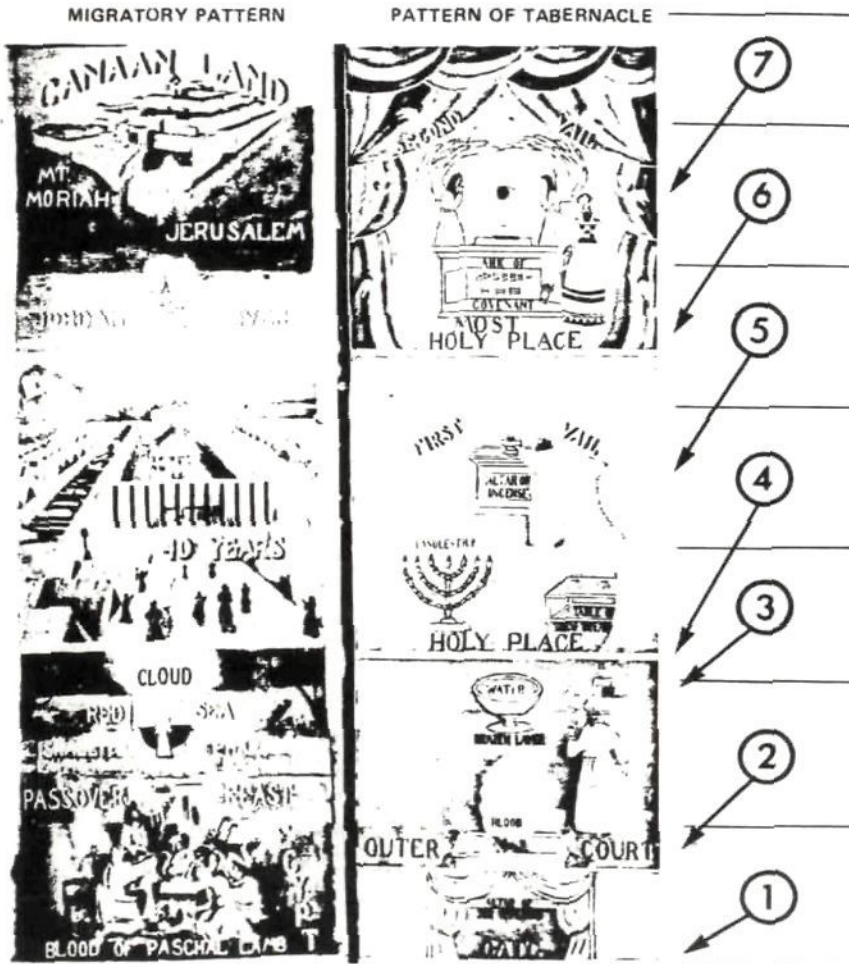
One can come to a conscious realization of how Yahweh-Elohim (Lord God) is operating and carrying out His Purpose and Plan down through the Ages and Dispensations by understanding that the Levitical High Priest performing his daily and yearly ministrations in the Mosaic Tabernacle was an analogy or type and shadow of Yahweh-Elohim (Lord God) who is the True and Only High Priest.

The Seven (7) Steps in the Mosaic Tabernacle are shown in the diagram above and on the following page. The brief explanation of each step on the following page shows how the

THE NUMBER SEVEN (7)

There are seven (7) steps, dimensions or planes often referred to as Heavens, whereas there are but three (3) Heavens (see 2 Cor. 12:1-4) which leads to Perfection. The seven steps, dimensions or planes are revealed in the Pattern of the Tabernacle, and in the Greater and More Perfect Tabernacle, the Universe (called the Migratory Pattern) which was pitched by Yahweh-Elohim and not the man, Moses (Heb. 8:2). "Therefore

leaving the principles of the doctrine of The Messiah, let us go on unto PERFECTION; not laying again the foundation of repentance from dead works, and of faith toward Yahweh. Of the doctrine of baptisms, and of laying on of hands, and of resurrection of the dead, and of Eternal Judgment" (Heb. 6:1,2).

The seventh plane is represented in the Migratory Pattern by the Israelites entering Canaan or the Promised Land, their final earthly inheritance, and is compared to the Most Holy Place in the Tabernacle, a type of Heaven and was fulfilled by Yahshua The Messiah, who entered not into the Holy Places made with hands, but into Heaven itself (Joshua 14:1-3; Ex. 26:34; Heb. 6:19-20 and Heb. 9:24).

The sixth plane is represented in the Migratory Pattern by the parting of the River Jordan forming the SECOND VAIL between the Wilderness of Sinai and Canaan Land, and is compared to the dividing Vail of Blue, Purple and the Scarlet which hung between the Sanctuary and Most Holy Place in the Tabernacle, and was fulfilled by Yahshua The Messiah when He took off the Vail of His flesh and ascended into Heaven (Joshua 3:1-17; Ex. 26:31-34 and Heb. 10:20).

The fifth plane is represented in the Migratory Pattern by the Wilderness of Sinai where Israel received the Law and Tabernacle with its ceremonies, with the Presence of Elohim among them, and is compared to the Sanctuary of the Tabernacle with its furniture for ceremonial purposes, overlaid with gold and fulfilled by Yahshua, who said, I am the Light of the world, the Bread of Life and Intercessor (Ex. 19:1-3; Ex. 24:12-14; Ex. 30:35-36; John 8:12; John 6:35; John 17th chap.).

The fourth plane is represented in the Migratory Pattern by the parting of the Waters of the Red Sea forming an entrance into the Wilderness, and is compared to the FIRST VAIL or DOOR of the Tabernacle, and was fulfilled by Yahshua The Messiah, who said, I am the DOOR, by me if any man enter he shall be saved (Ex. 14:21; Ex. 36:37; John 10:9).

The third plane is represented in the Migratory Pattern by the Baptism of the Israelites in the Cloud and in the Sea as they fled from the Egyptians, and is compared to the Brazen Laver in the Court of the Tabernacle for washing and cleansing purposes and fulfilled by Yahshua by washing the disciples feet (Ex. 13:21; Ex. 14:15-16; Ex. 30:18-21 and John 13:4-5).

The second plane is represented in the Migratory Pattern by the slaying and eating of the Paschal Lamb in preparedness to leave out of Egypt, and is compared to the Sacrifice of Sin offering on the Altar in the Outer Court of the Tabernacle, and was fulfilled by the prepared body of Yahshua, the Passover Lamb, slain for the Sins of the world (Ex. 12:1-12; Ex. 20:24 and 1 Cor. 5:7).

The first plane is represented in the Migratory Pattern by the DOOR or entrance into the houses of the Israelites, on which the Blood of the Lamb was put on the lintel and two side posts and is compared to the GATE or entrance into the Tabernacle, and was fulfilled by Yahshua when He said, enter in at the STRAIT GATE (Ex. 12:22; Ex. 40:8; and Mat. 7:13).

NOTE TO THE READER - BASIC PSYCHOLOGICAL PREPARATION

High Priest's duties were ordered which is a reflect of how Universal Spirit Law Operates and Functions in relative coordination with the Archetype Pattern, Yahweh-Elohim (Lord God). Now the brief explanation of the Seven Steps in the Tabernacle Pattern are correlated with the Israelites' Migration from Egypt to Canaan Land (typifying Heaven) and the Messiah's Mission and Purpose in the flesh which proves the Divine Authenticity, Unerring Accuracy and the Infallibility of this Pattern. No event happens by accident, chance, or helter skelter, but in accordance to the Seven Steps in this three-Fold Divine Tabernacle which repeat themselves over and over again repetitiously, just as the seasons of the year (Fall typifies a Death, Winter typifies a Burial, Spring typifies a Resurrection, Summer typifies an Ascension or Fruition) are ordered and constantly repeat themselves over and over again.

Thus it is a profound understanding of these simple Seven Steps (Function) and the three-Fold structure of this Divine Tabernacle Pattern that enables one to prophesy or know the next Foreknown and Predestined events that are to come in Yahweh-Elohim's Purpose with Unerring Accuracy and Infallibility. This three-fold Tabernacle Pattern is a Measuring Rod to which all things can be compared or correlated (Rev. 11:2). Hence the subject matter discussed herein, although it may be startling to some, is shown and proven in accordance to this Divine Tabernacle Pattern. One should also be cautioned that the writer refuses to make any diplomatic apologies for stating the Truth and Facts as they are told herein, and has no regard to one's previous concepts, imaginations or feelings because it is the writer's indispensable duty to tell the he Truth (John 8:22) and "let the chips fall where they may" as the founder, Dr. Henry C. Kinley stated many times. There is a brief history of the founder, Dr. Henry C. Kinley included on the next page for those that are ignorant of his Panoramic Vision and Divine Revelation.

BRIEF HISTORY

For the past forty-five (45) years our founder and dean, Dr. Henry C. Kinley, has told us, by the Divine Yahweh (God) given Pattern (which was revealed to him in the year 1931), the history of the world (ages), past, present, and future with Divine Authenticity, unerring Accuracy and Infallibility.

The Power of the Spirit Law, operating through the dean according to the Pattern has been demonstrated by the healing of all types of diseases, infirmities and deformities of men, many of whom are his present followers.

From this Pattern our dean has evolved a philosophical measuring rod which can be applied to events to occur with the same unerring accuracy. For example, in 1939 Dr. Kinley wrote President Roosevelt and asked him to investigate this work, proving everything operates according to this Divine Pattern. The President turned the letter over to the Smithsonian Institute for their investigation, they replied, stating they had no funds available for such research. When President Roosevelt ran for his fourth term, the Dean told us he would be nominated and elected, but would not be in the White House one year from the day he took office; he died April 12, 1945. He told us well in advance (1959) of the nomination, election and assassination of President John F. Kennedy; also the six day war in Israel (day by day). We, the followers of this truth, are witnesses of these aforementioned events, and so many other miracles, time and space would not permit to list them all.

By the operation of the Pattern the prophets predicted the events of human history to the birth of Yahshua the Messiah (Jesus Christ), and Daniel interpreted the King's dream and foretold the fall of an empire so vast as to seem impregnable. It was the loss of the Pattern which caused King Saul to consult the Woman at Endor and communicate with Samuel to learn of his downfall. It is the loss of this Pattern TODAY which has brought the world upon the brink of a cataclysm second only to the days of Noah.

The question you might ask is, "Everyone knows these events have happened" or "How come he didn't try to warn the people?". If we may take a few more minutes of your reading time to explain: Noah did warn the people for some one hundred and twenty (120) years; the Messiah (Christ) did warn the people in His time; and now our Founder and Dean was sent in these last days to warn the people. Remember the End was declared from the Beginning, the Scriptures must be fulfilled, all are called but few chosen.

Now is the acceptable time to call to the attention of man the unchangeable Will of Yahweh (God) as expressed in the Scriptures, void of man-made traditions and ritualistic ceremonialism. After all we should SEEK to know Yahweh (God) for ourselves as HE REALLY IS and as HE ACTUALLY EXISTS.

It was our Founder and Dean's indispensable duty given by Supreme Authority to awaken you to the consciousness that there is a way, there is a place, to learn how to unlock the mysteries of our Creator, Yahweh-Elohim. The functioning of the Divine Pattern is Eternal in operation, if we realized this one cardinal point, the world would not be perplexed as it is today.

All created objects of nature, visible and invisible, natural and super-natural, are governed by and operate according to the Divine Yahweh-Elohim (Lord-God) Original Archtype Pattern of the Universe.

ACKNOWLEDGEMENTS

In writing any orchestral work or symphony the Composer is inspired to write down what he has heard in his Heart and Mind (I Chron. 15:22, 16:7). INTRODUCTION

The Intent and Purpose of this paper (work) is to Show and Prove that the RETIREMENTS (DEATHS) of the Presidents in Office, and the Conception, Birth, Life and ULTIMATE FATE of this Country happen in accordance to a Divine Pattern (which is Yahweh-Elohim Himself "The Archetype (Original) Pattern of the Universe," Ex. 24:9-10; Matt. 17:1-9; John 2:18-21; Rev. 21:22, typified by the Three-fold Tabernacle Pattern, Ex. 25: 8-9, 40; Heb. 8:5), and the Eternal Purpose and Plan of Yahweh as laid down in the Law and Prophets (Isa. 8:20). We will also Show and Prove (Isa. 8:20) the RETIREMENT (DEATH) POSSIBILITY of PRESIDENT Ronald Reagan (40th President), AS THE LAST ELECTED PRESIDENT, who will be NOMINATED at the 33rd Republican Convention in Dallas, Texas. (NOTE: At the time this paper was written the Republican Convention had not convened.) He will be RE-ELECTED to the 49th Presidential Four-Year Term (1985-1989), since George Washington's First Term in 1789, and he will RETIRE (DIE) in Office, by this Divine Pattern and Eternal Purpose and Plan of Yahweh. We will explain according to the Scriptures (Isa. 8:20) why it is impossible for former Vice-President Walter Mondale (the Democratic Presidential Candidate) and Geraldine A. Ferraro (the First, Female, Vice-Presidential Candidate, who is Roman Catholic, and 49 years old) to Win or Defeat incumbent President Ronald Reagan and Vice-President George Bush.

Now Vice-President George Bush (43rd Vice-President) will

be President Reagan's successor to the Office of the President. President Bush (who will be the 41st President) will be faced with an Unparalleled Domestic and International Crisis, Economically and Politically, that will shake the Utter Foundation (the Constitution, Psa. 82:5; Rom. 1:19-20) of this Country and the Whole World, although the True Foundation can never be shaken (Isa. 28:16).

Economically, Christendom's (the West's) entire Banking System has been Grievously Burdened Down by or in Bondage to 800 Billion Dollars of Debt (Loans) Owed to it by the Third (3rd) World Nations, and they haven't the remotest possibility of Repaying this Debt (See Exhibits 1 and 2). As a result of this Grievous, Burdensome Debt, the Economies of Christian Nations have suffered the Malady of Rising Unemployment among its Workers, Deeper Recessions, and Anemic Economic Recoveries. Our question to the President is "How can an Economic System that is Burdened Down by such a Grievous, Overbearing DEBT Exemplify Growth, Strength, Vitality and Prosperity for All?" Unless Total Reform or Change (Jubilee or Pentecost, Lev. 25: 1-41; Neh. 5:1-13; Jer. 31:31-34; Rom. 1:19-20) takes place IMMEDIATELY the whole Western (Christian) World's Banking System will collapse and plunge the Entire world into a World-Wide Depression. The primary reason these Loans were lent by the Christian (West) Banking System to the Third (3rd) World Nations was to PREVENT them from going Communist (East; See "Armageddon by the Divine Pattern", pp. 21-22).

We in this Teaching understand that this Economic Crisis (or Malady) is just a PHYSICAL REFLECT (Rom. 1:19-20) of the

Jews under the Law being burdened down by the Law of Sin and Death (Rom. 7:13-14; Gal. 3:10-14; 4:21-25) which the Israelites couldn't keep, and which made NONE PERFECT as pertaining to his CONSCIENCE (Heb. 10:1-3, 7:11, 19). Thus it became necessary for the Mosaic Law to be Removed (Jer. 31:31-34; Heb. 8:7-13; 9:14-22) and Replaced by a Better or New Covenant (Jer. 31:31-34; Heb. 7:11, 19, 8:6-13; II Cor. 3:1-3). Yahshua the Messiah Fulfilled the Old Covenant (Matt. 5:17-18; Lk. 24:24-27, 44-45) through His Death, Burial, Resurrection, Ascension and the Outpouring of the Holy Spirit on the Jews in A.D. 33½ and on the Gentiles Seven Years later in A.D. 40½. The Outpouring of the Holy Spirit began this Present Kingdom Age, the Third (3rd) Age (World) in time, ushering Mankind into a NEW AGE where One Worships Yahweh in SPIRIT and TRUTH (John 4:21-24). In this Age Man is SAVED by Grace through Faith, and NOT OF WORKS of the OLD LAW of Moses (Eph. 2:8-9; Gal. 2:16-21, 5:18; Rom. 10:4). This Whole Age (Third Age or World in Time) has been deceived by Mystery, Babylon the Great, Mother of Harlots, and Abominations of the Earth, (Rev. 17:4-5; II Cor. 11:13-15; II Thess. 2:3-4) into Keeping the Law of Moses and the Worshipping of Saints (See Exhibit 3). Thus the Whole World is in bondage (Gal. 4:3, 9-10, 21-25; 5:1, 3) to the Law of Moses (Old Covenant, Acts 15:1-6) Thinking, Believing and Teaching (I Tim. 4:1-3; II Pet. 2:1) that SALVATION is obtained by WORKS rather than by GRACE through FAITH (John 6:28-29, 8:32, 14:6; Eph. 2:8-9; Acts 15:1-11, 19-29) in Yahshua the Messiah's Death, Burial, Resurrection and Ascension. We

see that the Third World Nations being in Debt or Bondage to the Western (Christian) Banking System is a Physical Reflect (Rom. 1:19-20) of the Whole World (3rd Age in Time) being in Bondage to the Law of Moses. Yahweh is showing us that NO SALVATION can be obtained unless one SEES AND BELIEVES that the DEBT (Wages of Sin, Rom. 6:23; Matt. 6:12, 18:23-35; Gal. 5:3; Rom. 8:12-14) of the Old Covenant is DONE AWAY WITH (FULFILLED, Matt. 5:17-18; Lk. 24:44-45; Heb. 9:14-22, 10:4-20 and PAID IN FULL) by the Messiah's Death, Burial and Resurrection. Hence there can be NO SALVATION, Carnally Speaking, for the Christian Banking System unless the Total Debt (loans) of the Third World Nations is FORGIVEN (Ezk. 18:7-8, 12-17; Lev. 25:47-55).

The Messiah came to Remove this Old Covenant of Sin and Death (Heb. 10:9) and give Eternal Life (John 10:10, 11:25), but the Elders of Israel desired to keep the people under the Law (Acts 15:1-6). The Messiah said to his disciples,

"...The Scribes and the Pharisees sit in Moses' Seat:...For they BIND HEAVY BURDENS AND GRIEVOUS to be born, and lay them on MEN'S SHOULDERS; but they themselves will not move them with one of their fingers." (Matt. 23:2, 4)

Likewise we see the Banks and Christian Nations typifying the Scribes and Pharisees who sat in Moses' seat, lending the Third World Nations more Money to Repay the Interest on these Loans (Not the Principal). As a result, the Third World Nations are being placed under even a Greater Debt or Burden of these added Loans -- a jackass can carry only so much. Some of the Third World Nations have tried Earnestly to Repay these Debts. They have burdened down their citizens with added living costs and

taxes. Due to this added burden, the citizens, however, have REVOLTED and RIOTED (II Chron. 10:1-19) in several of these Nations. The people are Underpaid, Underfed, Overworked, Overtaxed; and they refuse to take anymore abuse. This is an IDEAL BREEDING GROUND for Communism, carnally speaking. The Christian Nations and Banks (Ezk. 18:12-17, 22:12-13) have Devised Plans where they will Lower the Prime Interest Rate on the Loans and Stretch Out the Payment Period in hopes that the Third World Nations will eventually Repay them. The Law and Prophets Show and Prove that Israel couldn't repay the Debt (Psa. 38:4, 55:22; Isa. 22:22-25; Col. 2:14-17; Jer. 17:21-27) or Redeem (Lev. 25:47-55; Ruth 3:9-13; 4:1-17; Isa. 59:20-21; John 10:10-11, 18; Eph. 1:7, 11, 14, 18) themselves from their Sins under the Law of Moses. It took the Death of the Messiah, the Prepared Sacrifice for the Sins of the World (John 1:29; I Cor. 5:7; Rev. 3:14, 5:6). He said to Israel,

"Come unto me, all ye that LABOUR AND ARE HEAVY LADEN, and I WILL GIVE YOU REST. Take my YOKE upon you, and LEARN OF ME; for I am meek and lowly in Heart: and ye shall find REST unto your souls. For my YOKE is EASY, and my BURDEN IS LIGHT." (Matt. 11:28-30)

Thus it is foolish of the Christian Nations and Banks to devise and think these strategies will aid the Third (3rd) World Nations in Repaying their Loans, instead of Granting them TOTAL FORGIVENESS (JUBILEE) OF DEBTS OR LOANS (Neh. 5:1-13; See Exhibit 1). These vain schemes show their sheer Ignorance and Stupidity of Yahweh's Purpose and Plan. Due to Greed (Ezk. 22:12; Phil. 3:19; Jude 11), their planning is futile and will result in a Total Collapse of their Banking System

ENDING the Buying and Selling (See "Armageddon by the Divine Pattern", p. 18-23). The U.S. National Debt of \$1.6 Trillion (or over \$4,000 for every Man, Woman and Child of this country) is in the same state as that of the Third (3rd) World Nations' Debt, and Taxes will have to be substantially increased on U.S. citizens to Repay this Debt. No Economic System can take this Added strain without having an HEART ATTACK or STROKE.

The Political Crisis that President Bush will face is the further deterioration between the West (Christendom) and East (Communism, Russian Kremlin and Her Allies) which will be exacerbated by the Economic Crisis in this Country and in the World. As Profane history shows when times become hopeless, there has to be a Scape Goat (Lev. 16:21-22). The question is "Who will be the West's Scape Goat for the World's Problems?" The Communists? Both the Economic and Political Crises are Leading the World headlong into a "Universal Catastrophe" as our Founder Dr. Henry C. Kinley (who received a Panoramic Vision and Divine Revelation June 6, 1931) states in our Text Elohim, the Archetype (Original) Pattern of the Universe (Vol. IV, p. 82, first paragraph) and as is stipulated in everyones Bible, whether they Believe It or Not. It was prophesied by the Apostle John in A.D. 96, on the Isle of Patmos, in the 17th and 18th Chapters of Revelation that The Beast with the 10 Horns (i.e., the Russian Kremlin and her Allies) will Burn the Great City that sits upon Seven (7) Hills or Mountains (Rome), and it is confirmed by the Law and the Prophets (Isa. 8:20, see Red Book The Third World War, p. 65-73). No

Man can Impede, Stop or Change the Course of Events which were Set Up BEFORE the Foundation of the World by Yahweh-Elohim (Isa. 46:9-10; Rev. 3:14), the Archetype (Original) Pattern of the Universe.

In concluding the Introduction of this paper, I would like to mention to the Brethren how the topic of the Retirements (DEATHS) of Presidents in office was brought to my attention by the Holy Spirit. During a visit with Drs. Ed and Ethel Milbry of Stow, Ohio, January, 1984, Dr. Ed Milbry expounded unto me how the Death of the Presidents in office correlates with the High Priest's serving 20 years in the Tabernacle or Temple (Num. 4:3, 8:24-25). The High Priest entered his service at age 30 and retired at age 50. Dr. Milbry also prophesied that President Ronald Reagan would Retire or (DIE) in office. On returning home to Chicago I thought of these revelations deeply, but Yahweh had me to first finish the addendums to the Red Book The Third World War, which are "Aramgeddon by the Divine Pattern," "The Great Escape," "The Testimony of Yahshua is the Spirit of Prophecy," and "An Exegetical Analysis of Daniel's Prophecy of 1260 Days, 1290 Days, and 1335 Days". It was on my return from the Ohio State Convention, July 29, traveling West on the I-90 turnpike, that Yahweh Revealed to me how the Presidents Retired or (DIED) in office and the Ultimate Fate of this Country by the Pattern of the Tabernacle and the Purpose and Plan of Yahweh. What was Revealed is written on the following pages. May Yahshua, the Revealer of Mysteries (Dan. 2:47) Bless You with Understanding. MAY HIS NAME BE BLESSED FOREVER AND EVER AND EVER.

The United States of America, as profane history records, Declared its Independence from England July 2, 1776, by the Continental Congress, the governing body at that time. Two days later, July 4, 1776, the Declaration of Independence, (Isa. 61:1; Lk. 4:18; II Cor. 3:17; Gal. 5:1, 13) written by Thomas Jefferson at age 33 (typifying Yahshua's age in the flesh), was addressed 'to the opinions of Mankind.' We celebrate July 4, 1776 as the Birth of this Country and Government.

This Country, being a TYPE of the NEW WORLD (Rom. 1:19-20; Heb. 11:14-16), overthrew the yoke of bondage (II Chron. 10:1-9) of the Old World countries (such as, England, France, Spain, etc.), just as the Israelites by the aid of Yahweh overthrew the yoke of bondage of Pharaoh and his Host in Egypt (Deut. 5:6). Moses was told at the Burning Bush to tell Pharaoh to let the Israelites go on a three day journey into the Wilderness so that they could worship Yahweh (Exo. 5:3). One of the main reasons many people Migrated from the Old World (Europe) or were sent (expelled or banished) by various countries to the NEW WORLD was to Practice their various forms of so-called New Religion (Quakers, Baptists, etc.; See Exhibit 4) which conflicted with the Old World's National Religion, Roman Catholicism, Anglicanism, etc. In short, the comers to the NEW WORLD desired Religious Freedom (Isa. 61:1; Lk. 4:18; Gal. 5:1) to Believe and Practice as they wished without any Reprisal or Persecution. Keep in mind this NEW WORLD is only a TYPE OR PHYSICAL REFLECT (Rom. 1:19-20) of JERUSALEM ABOVE, the Mother of us All (Gal. 4:26). We know

that these so-called New Religions came out of their Mother (Roman Catholicism, Rev. 17:4-5) and they do operate by the Pattern, Purpose and Plan of Yahweh, as all things do (See Exhibit 4).

As the Israelites came through the Divided Waters of the Red Sea, after the slaying of the Paschal Lamb, they received the Law of Moses (Yahweh) at Mt. Sinai which governed the whole body of Israel (Ex. 19th and 20th Chapters). Likewise, in TYPE, the Pilgrims to the New World, who were being Killed and Imprisoned in the various European Countries (Old World in type) for Practicing any Religion other than the National Religion, Migrated across the Atlantic Ocean (likened unto the Red Sea by the Pattern) and came to the New World where they set up a NEW TYPE of Government, where Religious Freedom (Gal. 5:1) to Believe as one chooses was the Right of Each Individual (Jug. 17:6).

What governed the New World in its beginning after declaring its Independence (by the Declaration of Independence, Isa. 61:1; Gal. 5:1) was the Articles of the Confederation which can be correlated with the Law of Moses or the First Covenant. As the Children of Israel broke this Covenant by building the Golden Calf in the Wilderness (Ex. 32nd Chapter; Jer. 31:31-34) and this Law couldn't make a man Perfect pertaining to his Conscience (Heb. 9:20-27), it necessitated that Yahweh-Elohim Remove this Covenant and Replace it with a Better Covenant that is Written in the Hearts and Minds of Man (Jer. 31:31-34; II Cor. 3:1-3). As the early Founding Fathers

of this country soon found out, the Articles of the Confederation were inadequate for governing this country. One of the problems they encountered was the Debt (\$60,000,000 or 6, *i.e., in bondage to the flesh*) that had to be paid which had accumulated during the war of Independence with England. The Articles of the Confederation gave them no power to tax. This Debt is a Reflect (Rom. 1:19-20) of the Indebtedness (Gal. 4:21-25) of the Israelites to the Law of Sin and Death, until the Messiah came to Remove this Covenant (Law of Moses) by Fulfilling it (Matt. 5:17-18). All the problems under the Articles of the Confederation are just a Reflect of the Carnal Minded Jews (Rom. 7:14) interpreting carnally the Law of Moses, which was in Reality, Spiritual.

What replaced the Articles of the Confederation was the Constitution, ratified in 1789, which is a Reflect of the New Covenant (Jer. 31:31-34; II Cor. 3:1-3). NOTE: To see how the Constitution compares with the Pattern see The Springfield, Ohio Workshop Project of 1977, "The Rising Sun," Chapter Eight. The 12½ years between July 4, 1776, the publishing of the Declaration of Independence, and the Ratification of the Constitution can be correlated to the 12 Tribes of Israel that were under the Law who received the New Covenant (Jer. 31:31-34; II Cor. 3:1-3; Heb. 10:4-10, 16-20) or Outpouring of the Holy Spirit (Acts 2: 1-4) June 6, A.D. 33½ in Jerusalem, after the Messiah's Death, Burial and Resurrection. We see why the Constitution Was Successful since its Ratification because it is a REFLECT of the New Covenant (Jer. 31:31-34; II Cor. 3:

1-3), while the Articles of the Confederation was a failure just as the carnal minded Jews failed miserably trying to keep the Law, which was given to point out their insufficiencies or their sinful nature (Rom. 7:18). Before proceeding to examine the Retirements (DEATHS) of the Presidents in office, the Great Seal on the One Dollar Bill, the SYMBOL of this Nation, must be discussed, in accordance to the Divine Pattern and the Eternal Purpose and Plan of Yahweh.



The Founding Fathers were not conscious, nor had they the understanding of the Purpose, Pattern and Plan of Yahweh when they founded this country, yet these men (as all men are) were moved by Yahweh to reflect his Purpose (II Pet. 1:19-20). Let us examine "THE GREAT SEAL" on the One Dollar Bill. The Latin phrase "ANNUIT COEPTIS" means "He (God, more correctly Yahweh-Elohim) has Favored our Undertaking". Now Yahweh-Elohim did favor this undertaking, because the setting up of this nation was a PHYSICAL REFLECT (Rom. 1:19-20) of the Present Spiritual Kingdom Age governed by the New Covenant (Jer. 31:31-34; Heb.

8:7-10; Rom. 8:1-4, 14), which was set up by the Messiah's Death, Burial, Resurrection, Ascension and the Outpouring of the Holy Spirit in A.D. 33½, June 6, in Jerusalem, Establishing His Kingdom in our Hearts and Minds (I Cor. 6:19-20; II Cor. 3:1-3; Lk. 17:20; Matt. 12:28-29; Rom. 14:17).

The "EYE", which is the capstone of the Pyramid emanating brilliant Light correlates with Yahweh dwelling in the Cloud above the Mercy Seat of the Ark of the Covenant between the wings of Two Cherubim of Glory in the Most Holy Place in the Mosaic Tabernacle (Lev. 16:2; John 8:12; Rev. 21:23-24; Acts 1:9-11). The Light Emanating (John 8:12) from this "EYE" is correlated with the flashing of the Schechinah (Vision of Yahweh-Elohim in the Midst of this Cloud, Matt. 17:1-9; Acts 1:9-11; Lev. 16:1-2) that the High Priest saw in a Vision on the Day of Atonement (Lev. 16th Chapter) when he went into the Most Holy Place three times (for Himself, for the People, and the Cleansing of the Sanctuary) which let him know the Children of Israel's sins had been forgiven for that year. The Pyramid being used as a part of the "GREAT SEAL" points to the Great Pyramid of Gizeh in Egypt. (There are three Pyramids in all, along with the Sphinx, which in reality were built by Yahweh-Elohim, not the Egyptians, although they did build some others. The three Pyramids show the Three Times Yahweh-Elohim was manifest in a Physical Body (see Dr. Peter Goudeaux III's paper "How Yahweh-Elohim was Manifested in a Man on Three Occasions...", in the Red Book, The Third World War, p. 97-100).

Under the Pyramid on the back of the One Dollar Bill is

the Latin phrase "NOVUS ORDO SECLORUM" which means THE NEW ORDER OF THE AGES. We in this Teaching know that the Ages are ordered by the Divine Tabernacle Pattern which reflects the Spiritual Embodiment of Yahweh-Elohim, who is 'The Archetype (Original) Pattern of the Universe'. There are three (3) compartments in this Tabernacle: (1) the Court Round About, (2) the Holy Place or Sanctuary, (3) the Most Holy Place, making up ONE TABERNACLE NOT THREE. This shows that Yahweh-Elohim is the (1) Father, (2) the Word or Son, (3) and the Holy Spirit, in ONE UNIVERSAL SUPREME SPIRIT EMBODIMENT (I John 5:7) and NOT THREE PERSONALTIES OR A TRINITY. All matter must be derived from some definite Source and Substance which is SPIRIT. Now since the Spiritual Embodiment is three-fold (the Father, Word or Son, and the Holy Spirit) then Matter must also be three-fold since it is derived from Spirit, the Source and Substance. All Matter is composed of a (1) Proton, (2) Neutron, (3) Electron, making up one substance: Matter. There are three States of Matter (1) Gases, (2) Liquids, (3) Solids. Thus we see that a change in Manifestations or States of Matter doesn't change the fact that it is Matter. Likewise, Spirit (the Reality) has Three States:

- (1) Yahweh, the Father, with No particular shape or form, depicted as a cloud (Lev. 16:2; Matt. 17:5) is the Pure Spirit State. He is Incomprehensible and Inconceivable in this State.
- (2) Yahweh-Elohim, the Word or Son is Yahweh (Spirit) in Part (not Totality) taking on a Definite Shape or

Form of A MAN, which is seen in Visions and Revelations by the Prophets (Ex. 24:9-10; Matt. 17:1-9; Rev. 1:12-19). This Form is "Elohim the Archetype (Original) Pattern of the Universe".

- (3) Yahshua the Messiah is the Word or Son in a Fleshy Physical Body that can be seen or touched physically (John 1:14; I Tim. 3:16).

Living Matter, a Cell, is also three-fold and is composed of (1) Nucleolus, (2) Nucleus, (3) Cell Body, making ONE CELL and not three or a Trinity. Our Government consists of Three Branches (1) Judicial, (2) Executive, (3) and Legislative, making ONE Government and not Three. All things in this Universe, known and unknown, visible and invisible are three-fold because the Creator Himself, Yahweh-Elohim, the Archetype Pattern of the Universe, is three-fold in ONE UNIVERSAL SUPREME SPIRIT EMBODIMENT. This three-foldness of all things was stated to prove that the Ages are ordered by the Tabernacle Pattern. Thus, there are Three Ages in Time: (1) Ante-Diluvian Age, from Adam to the Flood, (2) Post-Diluvian Age from after the Flood to Yahshua the Messiah's Death, Burial, Resurrection, Ascension and the Outpouring of the Holy Spirit, (3) Present Spiritual Kingdom Age on Earth, from the Outpouring of the Holy Spirit to the Universal Revelation of Yahshua the Messiah from Heaven which Ends Time and Ushers us into the Realm of Eternity (Isa. 57:15). In the Realm of Eternity we are either Glorified or Damned (Rev. 20:10-15; Phil. 3:19-20) depending on whether or not we have received the Holy Spirit (Gal. 2:20)

while we are yet in the Flesh. (NOTE: There is no such thing as Purgatory, see our Text, Vol. IV, p. 105-107).

The Present Kingdom Age (which began with the Outpouring of the Holy Spirit on the Jews June 6, A.D. 33½, 9:00 A.M. in Jerusalem and Seven (7) years later in A.D. 40 when the Gentiles received the Holy Spirit) by the Tabernacle Pattern correlates with the Most Holy Place, since the Ages are ordered by the Pattern. What Yahweh-Elohim did in this Present Kingdom Age or 3rd Age in Time was to Establish the New Covenant which is written in the Hearts and Minds (Jer. 31:31-34; II Cor. 3:1-3; Rev. 3:20; Heb. 8:6-13; I Cor. 6:19-20). The New Order of the Ages (NOVUS ORDO SECLORUM) is Worshipping Yahweh in Spirit and Truth (John 4:21-24) and NOT BY PERFORMING Ceremonies, Eating so-called Lord Suppers, Getting Water Baptized and other Carnal Ordinances that were performed under the Dispensation of the Law in the Post-Diluvian Age which were Fulfilled (Matt. 5:17-18; Lk. 24:25-27, 44-45) and Nailed to the Cross (Col. 2:14) by Yahshua the Messiah's Death, who was the END of the Law of Moses (Rom 10:4). It was His Death (Heb. 9:14-18), Burial and Resurrection that brought an END to the Law of Moses and ushered us into a NEW ORDER OF THE AGES (NOVUS ORDO SECLORUM).

The United States (Heb. 11:16) was set up by Yahweh-Elohim with its Constitution (typifying the New Covenant, Jer. 31:31-34; Gal. 5:1; II Cor. 3:17) at the End of this Age, as a PHYSICAL REFLECT (Rom. 1:19-20) of this NEW ORDER OF THE AGES (NOVUS ORDO SECLORUM), Present Kingdom Age on Earth (Holy

Spirit in our Hearts and Minds - Matt. 12:28-29; Lk. 17:20; I Cor. 6:19-20; II Cor. 3:1-3) with its New Covenant. There has been no other Country set up with our Constitution that has worked, even though many other countries have tried to copy it without success. Now again we state, according to Yahweh's Purpose and Plan that this country was set up to be a PHYSICAL REFLECT (Rom. 1:19-20) OF THE PRESENT (SPIRITUAL) KINGDOM AGE on Earth Established by the Outpouring of the Holy Spirit after Yahshua the Messiah's Death, Burial and Resurrection. Thus, there can be ONLY ONE NATION (Heb. 11:14-16; Phil. 3:19-20) ON EARTH to be a Physical Reflect of this Present Kingdom Age or Canaan Land which was a type of Heaven by the Pattern. All the Physical Blessings this country has, such as its Wealth, Technological Advances, etc., are just Physical Types and Shadows of the Spiritual Blessings of one who receives the Holy Spirit (Eph. 1:3, 13-14; Rom. 14:17; John 15:16; Gal 5:22).

The banner in the Eagle's mouth with the inscription "E PLURIBUS UNUM" means "One Out of Many". Now the Spiritual Reality of this inscription can be correlated with Abraham being called out of the Ur of the Chaldees (Gen. 11:31, 12:1-3). Yahweh-Elohim called out one MAN from many to establish His Promise that he would make a Great Nation and give him a Seed, Isaac (typified by Yahshua the Messiah, Gal. 3:16) in which all Families of the Earth are Blessed. NOTE: Moses' name means to be 'drawn out' (Exo. 2:10). Now this Promise was Fulfilled on the Day of Pentecost (Acts 2:1-4) June 6, A.D.

33½, at 9:00 A.M. in Jerusalem with the Holy Spirit being Poured Out on the Jews, and seven years later on Gentiles in A.D. 40½ by Peter (Acts 10:44-45). (See also our Text, Vol. IV, The Carnal Ordinance Chart, opposite p. 54). We see that Yahweh created for Himself a People to Worship Him with Abraham being "The One Called Out". Physical Israel is a Physical Type (Rom. 1:19-20) of the Spiritual Jew (Rom. 2:28-29) being "The One Called Out" of the Many religions of Mystery, Bablyon the Great, the Mother of Harlots (Rev. 17:4-5). MANY ARE CALLED, BUT FEW ARE CHOSEN TO RECEIVE THE HOLY SPIRIT (Matt. 20:16, 22:14). This New Nation was created out of the Down-trodden (Deut. 7:6-8) from other nations as a PHYSICAL REFLECT (Rom. 1:19-20) of those being grafted (I Pet. 2:5; Rom. 11:17-24; John 15:1-8) into Yahshua the Messiah's Body after being called out of Mystery, Babylon the Great, the Mother of Harlots, and Abominations of the Earth (Rev. 17:4-5, 18:4). Thus the Principles on which the founding Fathers established this country were just PHYSICAL REFLECTS of the Spiritual Kingdom of Yahshua the Messiah that consists of those who have the Holy Spirit (Rom. 14:17). The Founding Fathers were not conscious of this, nor of the Purpose, Pattern and Plan of Yahweh as we have stated in this paper, any more than the Holy Prophets understood the Law and Prophets before the coming of Yahshua the Messiah (Rev. 5:1-7; Lk. 24:44-45).

The Thirteen Stars above the Eagle's Head (which correlate with the Original 13 Colonies) in reality point to the twelve Disciples and Yahshua the Messiah under the Dispen-

sation of the Law and also twelve Apostles of Spiritual Israel with the Messiah (Acts 2:1-4; Gal. 2:20; Matt. 28:19-20) in them under the Dispensation of Grace. Currently there are 50 (Pentecost) stars for the 50 states of the Union on the flag. Hawaii, an island of Paradise (typifying the Garden of Eden or being in the Spirit, Gen. 2:9-10; Rev. 22:1-2; John 15:1-8; Gal. 5:22) became the 50th state in 1960 - END of the Present Kingdom Age (Isa. 46:9-10), just as we were able to partake of the Fruits of the Spirit at Pentecost or the Outpouring of the Holy Spirit, which was the END of the Post-Diluvian Age.

The Eagle, the symbol of this Nation, points to Yahshua the Messiah as Moses writes:

"As an Eagle stirreth up her nest, fluttereth over her young, spreadeth abroad her wings, taketh them, beareth them on her wings: so Yah-Yahweh alone did lead Him, and there was no strange Elohim with Him." (Deut. 32:11-12; see Exo. 19:4; Isa. 40:31; Rev. 12:14).

The olive (o-live) leaves in the right claws (left claw when facing it) point to the fact that this is a Nation of Peace, in Type. This is a Physical Reflect of Yahshua the Messiah or Yahweh's Kingdom being Righteousness, PEACE and JOY in the Holy Spirit (Rom 14:17) meaning in One's Heart and Mind (I Cor. 6:19-20; Gal. 5:22-23). In the left claw of the Eagle (right claw when facing it) are arrows showing that this New Nation will go to War to defend herself and the Principles laid down in our Constitution. This is a Reflect of Yahshua the Messiah and his Spirit in us WARRING (Matt. 10:34) with the SATANIC SPIRITS cast out of Heaven and incarnated in Physical Bodies (Matt. 12:28). This War occurs by the Preaching of the

Gospel (Rom. 1:16-17; I Cor. 1:21-25, 15:1-4; II Cor. 10:3-6; Eph. 6:10-18). We have shown according to the Eternal Purpose, Pattern and Plan of Yahweh what the SPIRITUAL REALITY OF THE GREAT SEAL of the United States means. The Free Masons and others have their own interpretation of these symbols, which most of the Founding Fathers were, or Believed in to one degree or another, but without a Pattern there is no way of arriving at the Correct Divine Etymological Meaning of these Symbols of this Great Country (I Cor. 2:14). This concludes a brief history of the United States and its Great Seal in accordance to the Divine Pattern and the Eternal Purpose and Plan of Yahweh. We will proceed to examine the Retirements (DEATHS) of the Presidents in office.

Now most Scientific, Academically Trained Carnal Minded (I Cor. 2:14) American Historians are well aware of the Historical FACT that Presidents who were Elected every Twenty (20) Years starting with 1840 A.D. Retired (DIED) in office. This was the year that President William Harrison (9th President) was Elected to office. He was also the FIRST President to Retire (DIE) in Office. The Presidents who were Elected starting in 1840, which began the Twenty (20)-Year Election Cycles, and who Retired (DIED) in office, follow on the next page:

- 1) 1840 ELECTION OF PRESIDENT Harrison, (9th President)
- 2) 1860 ELECTION OF PRESIDENT Lincoln, (16th President)
- 3) 1880 ELECTION OF PRESIDENT Garfield, (20th President)
- 4) 1900 ELECTION OF PRESIDENT McKinley, (25th President)
- 5) 1920 ELECTION OF PRESIDENT Harding, (29th President)
- 6) 1940 ELECTION OF PRESIDENT Roosevelt, (32th President)
- 7) 1960 ELECTION OF PRESIDENT Kennedy, (35th President)
- 8) 1980 ELECTION OF PRESIDENT Reagan, (40th President)

NOTE: In 1980 President Reagan was Elected, and during his term there was an attempt on his life. If he is Re-Elected, will he finish his term??? This will be discussed later in this Paper. The only EXCEPTION of a President to Retire (DIE) in office and NOT BE ELECTED during the Twenty (20) Year Election Cycle is President Zachary Taylor (12th President), who Died in office 9½ OR 10 years After President Harrison's Death.

(See Exhibit 5)

None of the Academically Trained Historians understand WHY the Presidents that were Elected during these Twenty (20) Year Election Cycles Retired (DIED) in office. If they would be obedient and go to the Law and Prophets (Isa. 8:20) as Yahweh admonished, they would find their answer in accordance to the Eternal Purpose, Pattern and Plan of Yahweh. Most Historians find these Facts about the President Retiring (DYING) in office Fascinating and Intriguing, but without a Divine Vision and Revelation (Prov. 29:18) they will never see the SPIRITUAL REALITY (I Cor. 2:10-13).

Now let us proceed to Show and Prove the Divine Significance of these Twenty (20) Year Election Cycles according to the LAW, the PROPHETS (Isa. 8:20) and the Eternal Purpose, Pattern and Plan of Yahweh. Our Founder, Dr. H. C. Kinley

used the True Aaronite Priesthood, which operated under the Dispensation of the Law, to Prophecy of the Retirement Possibility (DEATH) of Pope John XXIII BEFORE June 6, 1963.

Dr. Kinley foretold of Pope John XXIII's Death in the 1961 Edition of our Textbook God, The Archetype (Original) Pattern of the Universe, published October, 1961. Pope John XXIII died June 3, 1963 A.D. See our Text, Vol. IV, p. 61 for the following quote and calculations:

"According to the Mosaic Law the High Priest started officiating at the age of thirty (30) and retired at the age of fifty (50). Num. 4:3; 8:24-25)"

50	=	LAW Retired High Priest at age of 50
- 30	=	High Priest under the Law must be 30 years old BEFORE being Anointed as High Priest.
20	=	Total length of time High Priest served under Levitical Priesthood...

NOTE: This page of the Text is included at the end of this Paper (See Exhibit 6).

Thus we see that the Presidents that were elected during the Twenty (20) Year Election Cycles eventually Retired (DIED) in Office. This correlates with or is a REFLECT of the Total Length of Years (20) the High Priest served under the Levitical Priesthood. It should also be noted by the Reader that ALL Presidents that were Elected during these Twenty (20) Year Election Cycles didn't all Die during the particular term that they were elected. President Lincoln was Elected in 1860 A.D. and Served his First Four-Year Term (1861-1865) in its entirety. He was Re-elected in 1864 for his Second Term and was assassinated 42 days after being sworn into office. The Principle is that the President that is Elected during One of these Twenty (20) Year Election Cycles Retires (DIES) in

office no matter how many terms he's served--thereafter or before.

Now the First President to be Sworn in under the United States Constitution was George Washington in April 30, 1789. He served Two (2) Terms or 8 years.

The FIRST PRESIDENT TO RETIRE (DIE) IN OFFICE was President William Harrison (9th President). He was Elected in 1840 A.D. and was Sworn into office March 4, 1841. He Died April 4, 1841, after serving 32 days. For calculation purposes he served 34 days because Vice-President John Tyler was not Sworn into the office of President until April 6, 1841, two (2) days after President Harrison's Death. These thirty-four (34) days that President Harrison served in office BEFORE HIS RETIREMENT (Death) correlates with the 33½ or 34 years (1 day = 1 year; Num. 14:34) of Yahshua the Messiah's Life in the Flesh BEFORE He was Crucified. The Messiah Fulfilled Carnal Ordinances and the Levitical Priesthood which was a TYPE (Rom. 1:19-20) by His Death, Burial and Resurrection (Matt. 5:17-18; Lk. 24: 25-27, 44-45; Heb. 9:10; Col. 2:14-17). This began His reign as the High Priest After the Order of Mechizedek, which has NO BEGINNING AND NO END (Heb. 5:8-10, 7:1-3, 11-28).

President Harrison by occupation was a Professional Soldier. At eighteen (18) he enlisted as an army officer where he fought against the Northwest Indian Confederation in the successful campaign that ended in the Battle of Fallen Timbers near present Maumee, Ohio (Aug. 20, 1794). He was appointed governor of the newly created territory where he served for

eleven (11) years. With the country expanding, a growing demand for land by whites caused Harrison to renegotiate a number of treaties with the Indians. Resisting expansion of whites, the Shawnee inter-tribal leader, Tecumseh, organized an Indian uprising. General Harrison defeated the Indians at the Battle of Tippecanoe (Nov. 7, 1811) near present Lafayette, Indiana. This victory established his military reputation in the public mind. A few months after this battle the War of 1812 broke out with Great Britain. The Indians united with the British and both were decisively defeated at the Battle of Thames in Ontario where Tecumseh was killed.

General Harrison's Conquest of the Indians and the Giving of the land to the White Settlers is a Reflect of Joshua Son of Nun Conquering the Gentile Nations in Canaan Land and Giving the Israelites their inheritance (Josh. 14:1-3, 24th Chapter). This was fulfilled by Yahshua the Messiah Resurrecting over Death, Hell and the Grave, and the Souls (Sons) in the graves Resurrecting AFTER His Resurrection (Matt. 27: 51-53). They reigned with Him One Day (1 day = 1000 years, II Pet. 3:8; Rev. 20:6) in Jerusalem where they Appeared to many in Visions (I Cor. 15:5-8). Our inheritance now is the Holy Spirit in our Hearts and Minds (Eph. 1:13-14; Col. 1:26-27).

Now there were 52½ years from the Ratification of the Constitution (1788) to the Death of President Harrison (April 4, 1841), who was the First President to Retire (DIE) in office. (NOTE: For calculation purposes, the 52½ years will be rounded off to 53 years.) This 53 year period corre-

lates with Yahshua the Messiah's 3 days and 3 nights in the Earth (Matt. 12:38-41) plus the 50 day period between His Resurrection and the Outpouring of the Holy Spirit (a total of 53 days/years = 3 days and nights + 50 days; Num. 14:34, 1 day = 1 year) which began this Present Kingdom Age (Acts 2:1-4). Thus we see according to the Levite Priesthood and the Purpose and Plan of Yahweh, the Retirement (DEATH) of President Harrison happened "right on time". We must recognize that the Messiah was cut-off in the Prime of Life for the Prophet Isaiah states:

"...who shall declare His generation? for He was cut off out of the Land of the Living; for the transgression of my people was He stricken" (Isa. 53:8; Acts 8:33).

The next President to Retire (DIE) in office was Zachary Taylor (12th President). He served 1 year and 127 days or 492 days (March, 1849 - July 9, 1850) BEFORE he Retired (DIED). He was an officer in the Army and fought against the Indians in many wars. President Taylor is the only President Elected to office who Retired (DIED) and was NOT Elected during the Twenty (20) Year Election Cycle starting from 1840. President Taylor Retired (DIED) 9½ years (or 10 years for calculation purposes) after President Harrison was Sworn into the office of President and Died. This correlates with and is a REPEAT OR REFLECT of the 10 years to the day, After Yahshua the Messiah's Death, Burial and Resurrection, of the Apostle Peter's Imprisonment by King Herod and Peter's RELEASE by the Angel Michael (Reconfirmation of Yahshua's Resurrection, Acts 12:3-11; see Vol. I, Forty Plate Chart, folded inserts opposite

p. 128, Plate #35). We see according to the Purpose and Plan of Yahweh that President Zachary Taylor's Retirement (DEATH) in office was "right on time."

President Taylor being the 12th President correlates with the Twelve (12) Apostles of Yahshua the Messiah under the Dispensation of Grace. The 492 days of President Taylor's term before he Retired (DIED) in office (rounding off 492 days to 490 days for calculation purposes) is correlated with Daniel's 70 week Prophecy ($70 \times 7 = 490$ years; Dan. 9:24; 1 year = 1 day, Num. 14:34) which REPEATS over and over down through the Ages and Dispensations. It was Fulfilled (Matt. 5:17-18) by the Messiah starting with Artaxerxes' Commandment to Rebuild Jerusalem in 457 B.Y. (Before Yahshua) to the Day of Pentecost 33 A.D. ($457 \text{ B.Y.} + 33 \text{ A.D.} = 490$ years) when the Holy Spirit was Poured Out or the Spiritual Temple was Dedicated (I Cor. 6:19-20; Acts 2:1-4).

President Abraham Lincoln, a lawyer by occupation, was the 16th President of the United States and the third to Retire (DIE) in office. He was also the First President to be assassinated in office. Lincoln was Elected to his First Term in 1860, and (this necessitated that he Retire in office, for this is Twenty (20) Years after 1840 when President Harrison was Elected to office. He served only 42 days of his Second Term, and his total time as President was 4 years and 42 days (March 4, 1861 - April 15, 1865). Lincoln was assassinated by John Wilkes Booth (Boot - Foot, Satanic image struck on the foot, Dan. 2:34-35, 44-45) on April 14, 1865, the Passover,

at the Ford Theater in Washington, D.C. He Died the Morning of April 15, 1865.

NOTE: The word "Ford" means to cross a body of water or a passage, by wading. The word "Ford", in principle, is a Physical Reflect of the Children of Israel crossing the parted Jordan River on Dry Ground (Joshua 3rd Chapter) and was fulfilled by the Messiah Rending the 2nd Vail (6th Step in the Pattern or the Vail of the Flesh) from Top to Bottom after his Resurrection (Matt. 27:51-52; Heb. 10:19-20). It is no coincidence that President Ford (which means spiritually to Rend the 2nd Vail) had to Pardon President Nixon as a Repeat of Yahshua the Messiah Pardoning (Isa. 55:17; Jer. 50:20) our Sins after Rending (or Fording) the Vail of the Flesh (Heb. 10:4-20). All things Reflect the Purpose, Pattern and Plan of Yahweh. No Carnal Minded Historian can explain the ultimate reality (Spirit) of why President Ford pardoned President Nixon or why President Lincoln was shot at Ford Theater. It was after his death at Ford Theater (2nd Vail) that the slaves were freed (See the Emancipation Proclamation), as after Yahshua's Death, Burial and Resurrection, the souls held captive were set free (Isa. 61:1).

Booth shot Lincoln (Satan Bruising Yahshua's Heel, Gen. 3:15) in the Head, and Booth was caught and hung as Judas hung himself (Yahshua Bruising Satan's Head, Matt. 27:3-10).

President Lincoln's Term is clearly a REFLECT of the Purpose and Plan of Yahweh. When Lincoln took office the Country was Divided on the Issue of Slavery. The North had No Slaves (Ezk. 27:13; Rev. 18:12-13), and they wanted the Slaves in the South to be freed. The South Needed Slaves to work the fields, since agriculture (Gen. 3:17-19, 4:2-3) was the basic industry there. This is correlated with or a REFLECT of the Mission of Yahshua the Messiah who came to Redeem Israel from the Bondage of the Law of Sin and Death by Fulfilling (Matt.

5:17-18; Lk. 24:27, 44-45; Heb. 9:10-22; Col. 2:14) it and Moving it out of the way (Jer. 31:31-34; Heb. 10:5-10). The Elders, Scribes, Pharisees, etc. desired to KEEP Israel under the BONDAGE of the Law of Sin and Death, with themselves as the HEAD (Matt. 23:1-7). In Council the HEADS of Israel, the chief Priests, Elders, etc., decided among themselves (Matt. 20:17-19, Acts 4:25-28) on how they might KILL the Messiah (the Good Shepherd, John 10:1-11). They (the Chief Priests, etc.) thought with their carnal minds (Satan and his Host) that the people would follow them after Yahshua's death (Matt. 26:31). They were unconscious of the fact that they were Fulfilling the Scriptures (Isa. 8:20; Matt. 5:17-18; Lk. 24:25-27, 44-45) when they Crucified the Messiah, who was the Paschal Lamb (I Cor. 5:7; John 1:29; Rev. 13:8) that was offered up on the Passover morning, April 14, 33½ A.D. Lincoln was Killed on the Passover, April 14, 1865, as a REFLECT. Thus the Country Divided between Slavery in the South and Freedom in the North (Gal. 4:21-31) was just a REFLECT (Rom. 1:19-20) of the Chief Priests, Elders, etc. (Beast, Dragon and False Prophets - Rev. 16:13-14, 16; Acts 4:25-28) desiring to keep Israel in Bondage (Gal. 3:1-5, 4:3, 8-11, 24-25, 5:1, 3-4; Acts 15:1-5) under the Law of Moses (Sin and Death) versus Yahshua the Messiah who wanted to give LIBERTY (Isa. 61:1) and Eternal Life (John 10:4, 10-11, 17-18, 11:25, 17:1-3) through His Death, Burial, Resurrection and Ascension (Rom. 7:1-4; 8:1-4).

President Lincoln fought the Civil War to bring the South

back into the Union (under the Constitution, a type of New Covenant, Jer. 31:31-34) which they had DIVORCED OR SEVERED THEMSELVES FROM AND FORMED THEIR OWN Government (Deut. 24:1; Isa. 51:1; Jer. 3:8; Hos. 2:2, Rom. 7:1-4). This was a REFLECT of Yahshua the Messiah Fulfilling the Battle of ARMAGEDDON (Rev. 16:13-14, 15; Acts 4:25-28; Matt. 20:17-19; Psa. 2:1-2, 22:12-16) where the Beast, Dragon, and False Prophets Gathered the Kings of the Earth to do Battle against Yahweh by Crucifying HIS SON (the WORD Made Flesh, John 1:14) or Bruising the Heel of the Woman's Seed (For details see "Armageddon by the Divine Pattern", p. 1-14, 40-43). Yahshua the Messiah Achieved VICTORY over the Beast, the Dragon, and the False Prophets (Rev. 16:13-14) by Resurrecting over Death, Hell and the Grave (Isa. 25:8; Hos. 13:14; I Cor. 15:54-57) or Bruising the Serpent's HEAD. Thus the North's Victory over the South was just a REFLECT of Yahshua the Messiah's Victory over Satan and his Host or Bruising the Head of the Serpent's Seed (Gen. 3:15). It was by the North's Victory over the South that President Lincoln was able to Free the Black (Negro) Slaves. This is just a PHYSICAL REFLECT (Rom. 1:19-20) of Yahshua the Messiah "proclaiming LIBERTY to the Captives, and the opening of the PRISON to them that are Bound" (Isa. 61:1; see Matt. 27:51-53; I Cor. 15:54-57).

There were Fifteen (15) Presidents before Lincoln. This correlates with the three (3) Pentecosts (50; $3 \times 50 = 150$ or 15, zeros have no value in Divine Calculations) during the three years Yahshua the Messiah was in his Ministry Fulfilling

the Law and Prophets, BEFORE His Death, Burial, Resurrection, Ascension and Outpouring of the Holy Spirit on the Day of Pentecost June 6, 33½ A.D. in Jerusalem, at 9:00 A.M. This established the Kingdom of Yahweh in the Hearts and Minds of the Sons (Jer. 31:31-33; II Cor. 3:1-3; Eph. 1:13-23; I Cor. 1:21-25; Rom. 1:16) or released the Captives from Prison (Isa. 61:1; Matt. 27:51-53). Vice-President Andrew Johnson served the remaining part of Lincoln's term. There are many other correlations between President Lincoln and Yahshua the Messiah, but there is neither time nor space in this Paper to pursue a detailed investigation of this, for this is not the intent of this Paper. I hope that those whose Pure Minds are stirred up (II Pet. 3:1; I Cor. 2:10-13) would do a detailed investigation of President Lincoln's Life and this Country's history.

The next President to Retire (DIE) in office was President (James A. Garfield (20th President). President Garfield was Elected in 1880 and was the third (3rd) President to be Elected to office during the Twenty (20) Year Election Cycle starting from 1840. After serving only four months in office, he was shot on July 2, 1881, at the railroad station in Washington D.C. by Charles J. Guiteau, a disappointed office seeker. Guiteau shouted (Lk. 23:20-23) that he was a "STALWART" (a follower of Ulysses S. Grant, 18th President, 1869-1877) and wanted Chester Arthur, who was then the Vice-President, to be President (Mark 15:7). Guiteau was later tried, convicted and executed (Matt. 27:3-10).

Garfield's long disability raised the problem of Presidential succession for the first time in U.S. History. For 80 days the President lay incapacitated and performed only ONE OFFICIAL ACT, the signing of an extradition paper. It was agreed that the Vice-President was empowered by the Constitution to assume powers and duties of the Office of President. But the question that arose was, "Should the Vice-President serve merely as an Acting President until Garfield recovered or would he receive the office itself and thus displace his predecessor?" Because of an ambiguity in the Constitution and the precedent established in 1841 when, after the death of President William Henry Harrison, the Vice-President took the oath of Office as President, opinions were divided. Congress was not in session so the matter couldn't be debated. No action was taken on a successor until Garfield died September 19, 1881 after serving 199 days. (He was sworn in March 4, 1881.)

The Assassination of President Garfield by Charles J. Guiteau is a Reflect of the Sanhedrin Council, Pilate and King Herod Crucifying the Messiah (Acts 4:25-28) and Guiteau's execution points to Judas Iscariot hanging himself (Matt. 27:3-10). The Eighty (80) days President Garfield lay in a coma after performing ONE OFFICIAL ACT is a reflect of the New Beginning, which is the 8th Day or 1st Day after the Seven Sabbaths ($7 \times 7 = 49$, $49 + 1 = 50$), the New Age, or the Present Kingdom Age when the Jews received the Holy Spirit. This Ended the Spiritual Death (Coma or Incapacitation) that the Jews (and 7

years later the Gentiles) were under from Adam (Rom. 5:12-14). Now the ONE OFFICIAL ACT that President Garfield performed before being Assassinated is a Reflect of Yahshua the Messiah's Mission of Fulfilling (Matt. 5:17-18; Lk. 24:23-27, 44-45) the Law and Prophets, after which he was Crucified, Buried, and Resurrected the Third Day. The Country being in a dilemma about the President's successor is a Reflect of Yahshua the Messiah leaving NO successor in the Flesh (Dan. 2:44; John 14:26; I Tim. 2:5) and of the disciples picking Matthias (Acts 1:15-26) to replace Judas without Divine Instruction from the Holy Spirit. President Garfield's Death was right on time in REFLECTING the Levitical High Priest's Retirement under the Law. His death also pointed to Yahshua the Messiah's fulfilling of or putting an END (Retirement) to the Levitical Priesthood by his Death, Burial and Resurrection (Heb. 7:11-28).

The next President to Retire (DIE) in Office was President William McKinley (29th President). He was Elected to his First Term as President in 1896 and again in 1900. He was Assassinated on September 14, 1901, 194 days after being Sworn into his Second Term on March 4, 1901. President McKinley served 4 years and 144 days (March 4, 1897 - September 14, 1901). He was fatally shot on September 6, 1901, by Leon Cyolgozy, an anarchist (Mark 15:7).

In the Election of 1920 (which is the 33rd Presidential Election starting from the first Presidential Election in 1788 with George Washington), President Harding (29th President)

was Elected. He Retired (DIED) in Office August 2, 1923 after being Sworn into office on March 4, 1921. This is "right on time" in accordance to the Twenty (20) Year Election Cycle which shows the Unerring Accuracy of Yahweh's Purpose, Plan and Pattern.

The next President to Retire (DIE) in office was Franklin D. Roosevelt (32nd President). He was Elected to his First Term as President in 1932 and to his Second Term in 1936. He was Elected to his Third term as President in 1940. As the previous five (5) Presidents that were Elected during each of the Twenty (20) Year Election Cycles starting with 1840, died in office, President Franklin D. Roosevelt was NO EXCEPTION (Dan. 2:21, 4:17-18). He died on April 12, 1945 after being Elected to a Fourth (4) Term in 1944. His Death was Propheesied by Our Founder (See Red Book The Third World War, p. 20). President Roosevelt was the Longest Serving President to hold Office, 12 years and 39 days, which would have been 16 years had he finished his Fourth Term as President. President Truman (Roosevelt's Vice-President) was the 33rd President that finished his term and Ended World War II (see Red Book The Third World War, p. 26-32).

In the Presidential Election of 1960 (the Seventh (7th) Twenty (20) Year Election Cycle starting with 1840), which was the END of this Present Kingdom Age, John F. Kennedy (35th President), was the First Roman Catholic, to be Elected to the Office of President. Like all the Previous Presidents (Six) that were Elected during the Twenty (20) Year Election Cycle

starting in 1840 and Retired (DIED) in office, President Kennedy Retired (DIED) after being Assassinated in Dallas, Texas, on November 22, 1963. Our Founder Prophesied that a Roman Catholic would be Nominated, Elected and Assassinated in office. (For details of the Prophecy by the Pattern, See Dr. Peter Goudeaux III, "How Yahweh-Elohim Was Manifested in a Man on Three Occasions...", in the Red Book The Third World War, p. 94-95). The Holy Father at this time (1960) was Pope John XXIII, who our Founder also prophesied would not see June 6, 1963 and he Died June 3, 1963 (See our Text, Vol. IV, p. 61). Historians have found that there are many similarities between President Lincoln and President Kennedy. For instance, both had Vice-Presidents whose last names were Johnson that finished their terms. President Lincoln was Elected in 1860 and President Kennedy was Elected in 1960, ONE-HUNDRED YEARS APART or two (2) Pentecosts ($2 \times 50 = 100$), and both were Assassinated in office (See Exhibit 7). What these Carnal Minded (I Cor. 2:14), Trained Historians don't understand is that President Kennedy's and Lincoln's terms are a REPEAT of the Purpose and Plan of Yahweh, which repeats itself over and over again (Mal. 3:6; also see Text, Vol. IV. p. 66, first paragraph).

The Last Twenty (20) Year Election Cycle in this Age was 1980, which was 20 years into the Probationary Period, from the END of the AGE in 1960 (Vol. I, p. 119, #18, "Tsaddi"). The Ante-Diluvian Age had a Probationary Period of 120 years, from the time Noah began to preach until the Flood (Gen. 6:3,

11-13). President Ronald Reagan (40th President), the oldest man ever to be elected at age 69, was Elected to office with his Vice-President George Bush (43rd Vice-President). Many Historians WARNED him about being Elected during this 20 year Election period. There was an Attempted Assassination (March 30, 1981 in Washington, D.C.) on his Life during his Term. If he is Re-Elected to a Second Term in 1984 (which he will be), then he is NO EXCEPTION to this Twenty (20) Year Election Cycle in which ALL Presidents that were Elected starting from 1840, Retired (DIED) in office by this Immutable, Infallible, Unerring Spirit Law. President Reagan MUST ALSO Retire from office and there are no IFS, ANDS and BUTS about it because it is according to Yahweh's Purpose. We will discuss and prove later in this paper why according to Yahweh's Purpose and Plan President Reagan in 1984 will be Re-Elected and have to RETIRE (DIE) in office. We shall also show why former Vice-President Walter Mondale, WILL NOT WIN the Presidency according to the Purpose of Yahweh.

Before examining President Ronald Reagan's Election in 1980, his Re-Election in 1984, and its significance with the Purpose, Pattern and Plan of Yahweh, we will examine President Richard Nixon's (37th President) Resignation (Retirement) from Office on August 9, 1974 at Noon. He was the only President to Resign (Retire) from office. Since we in this Teaching have a Divine Pattern which is Elohim Himself, it must explain all things in Heaven and Earth, visible and invisible. Our Founder stated in our Text, Vol. I, p. 57, first and second paragraphs the following:

"...Every event in the past, present, and that which is to come was Foreknown and Predestined by the Yahweh-Elohim of this Stellar Universe, and precisely carried out, according to the design and operation of the Divine Pattern of the Tabernacle...

The performance of the Levitical Priesthood, according to the Law in the daily and yearly ministration, operating in and out of the Tabernacle (and Temple) as shown in Plate No. 1, was given to the Israelites under the Dispensation of the Law. It is by a Knowledge of the operation of this Pattern that we can know, how Yahweh has carried out His Purpose from the beginning or before the earth was, down to the Present time, and what will be ITS ultimate end (Eph. 1:10-11)."

President Richard Nixon (37th) was Re-Elected to his Second Term as President in November, 1971 and sworn into office January 20, 1972. The 1972 Presidential Term (1972-1976) was an important Physical Reflect in the Purpose and Plan of Yahweh for this country. Remember, the United States Declared its Independence from England by Publishing the Declaration of Independence on July 4, 1776. It was written by Thomas Jefferson who was 33 years of age (Isa. 61:1; Gal. 5:1).

July 4, 1776 = Date of Independence or Birth of this Country

+ 196 years = 4 X 49 years or END

1972 = Time from Birth of United States to and END of 196 year cycle

In order to understand the significance of 1972 being 196 years from 1776, one needs a PROFOUND UNDERSTANDING OF THE 1960 YEAR CYCLE (4 X 490 year cycle) or 196 year cycle (zeros have no value, 4 X 49 years) and the 70 weeks' Prophecy of Daniel (Dan. 9:24). Daniel's Prophecy of 70 weeks (70 X 7 years = 490 years or 49 years) is the PRINCIPLE OF A TIME PERIOD FIXED BY YAHWEH FOR DEDICATING A TEMPLE OR TABERNACLE

(for details of the 490 year cycle and 1960 year cycle see the Red Book The Third World War, p. 75-80, and Text, Vol. IV, p. 46-47).

Now there are Four (4) sets of 490 year cycles (4 X 490 years) in the Post-Diluvian Age starting with the Birth of Abraham (1995 B.Y.) to Yahshua the Messiah's Death, Burial, Resurrection and Outpouring of the Holy Spirit which ENDED the Law of Moses (Col. 2:14-18; Rom. 10:4) and the Post-Diluvian Age. Now the 490 year cycles in the Post-Diluvian Age are as follows:

- 1)* Birth of Abraham (1995 B.Y.) to Dedication of Tabernacle (1490 B.Y.)
- 2) Dedication of Tabernacle (1490 B.Y.) to Dedication of Solomon's Temple (1000 B.Y.)
- 3) Dedication of Solomon's Temple (1000 B.Y.) to Dedication of Zerubbabel's Temple (510 B.Y.)
- 4) Artaxerxes' Edict to Rebuild Jerusalem (457 B.Y.) to A.D. 33, the Outpouring of the Holy Spirit

*NOTE: See Text, Vol. IV, p. 46 and the Red Book "The Third World War", p. 75, 1995 B.Y. - 1490 B.Y. = 505 years - 15 years Ishmael was born before Isaac (the Promised Seed) = 490 Years

Thus, 4 X 490 year cycles = one 1960 year cycle or a 196 year cycle is an END of the Post-Diluvian Age and the Birth or the Drawing Out of the New Creature (II Cor. 5:17; Rev. 21:1-2; Acts 2:1-4).

There are also Four (4) sets of 490 year cycles or one 1960 year cycle in the Ante-Diluvian Age IN PRINCIPLE (not in chronological years) since the Ante-Diluvian Age is only 1656 years long. Adam lived 930 years (Gen. 5:5) which is 50 years short of 980 years which is TWO (2) 490 year cycles. Now Noah

was 480 years old when he received the Vision from Yahweh that it was going to rain and Divine specifications and instructions to build the Ark. He was the 10th generation from Adam, thus:

480 years = Age of Noah when he had the Vision
 + 10 = Number of generations Noah was from Adam (See Gen. 5th Chapter)

490 years Cycle with Noah's vision

This is the THIRD (3rd) 490 year cycle in the Ante-Diluvian Age. The FOURTH (4th) 490 year cycle in the Ante-Diluvian Age Closed the Age.

120 days/years = Noah preached
 360 days = 1 year or 360 days (Hebrew Time)
 + 10 days = Time the flood covered the earth (1 year and 10 days)
 490 days/years = Ark settled on Mount Ararat

NOTE: 1 day = 1 year (Num. 14:34; Ezk. 4:6)

so,

4 X 490 year cycles = 1960 year cycle = END of the Ante-Diluvian Age

Our Founder said 1960 A.D. (4 X 490 years or 1960 years from the Birth of the Messiah) was the END of the Present Kingdom Age (see Vol. I, p. 119, #18, Tsaddi), but this Age does have a Probationary Period. We can conclude by Proof and Evidence that 4 X 490 years (days) or 1960 year cycle or 196 years represents an END OF AN AGE. In summary, as is stated on the next page,

1960 Year Cycle = 4 X 490 Year Cycles = END of Ante-Diluvian Age or from Adam to the Flood

1960 Year Cycle = 4 X 490 Year Cycles = END of Post-Diluvian Age or from Birth of Abraham to Outpouring of the Holy Spirit A.D. 33½

1960 Year Cycle = 4 X 490 Year Cycles = END of Present Kingdom Age or from the Birth of Yahshua to 1960 A.D.

1960 Year Cycle = 4 X 490 Year Cycles = END of the Anti-Messiah's reign on Earth??? or from the Outpouring of the Holy Spirit June 6, A.D. 33½ to 1993½ A.D. = 1989½ A.D. + 4 Year error

Now returning to our original thought, the BIRTH OF THE UNITED STATES was July 4, 1776. By adding the 196 year cycle to this date 1776, we have 1972, which is an END of this cycle, and there must be some Reflect (Rom. 1:19-20) of an END of an Age. President Nixon was Re-Elected to office and he couldn't complete or finish his Second Term (1972-1976) because it was a REFLECT of Yahshua the Messiah being cut off (Isa. 53:8; Dan. 9:27) in the prime of his life (at 33 years old) or 1960 years from the birth of Abraham. It was Yahshua the Messiah's Death that brought an END or RETIREMENT of the Levitical Priesthood (Heb. 7:11-22) and Established a New Order of Priesthood after the Order of Melchizedek with Himself (Yahshua) being the High Priest and King (Heb. 5:5-10). Thus, we see the RESIGNATION (RETIREMENT) of President Nixon (a Quaker by Religion who does not believe in Carnal Ordinances and whose religion is the closest to the Truth in the Earth Plane) is a REFLECT OF YAHSHUA THE MESSIAH RETIRING OR ENDING

THE LEVITICAL PRIESTHOOD (Heb. 7:11-22) and EXPOSING THEIR HYPOCRISY (Matt. 23:1-33; Col. 2:14-17), under the Law, by His Death, Burial and Resurrection, as Nixon was Exposed by Water-gate when he broke the Law of the Land, the Constitution, which he tried to cover up (Gen. 3:7-11, 4:9-10; II Cor. 5:3). Congress (who makes the Laws) was going to IMPEACH him for violating the Law, just as Yahshua (being the LAW of the Spirit of Life) who came to Remove the LAW OF SIN and DEATH (Rom. 8:1-4; Heb. 7:11-22) was Impeached or Crucified by the Elders of Israel (Matt. 23:1-7, 26:57-68).

Now President Nixon was the 37th President. He Resigned from office thirteen (13) years AFTER the publishing of our Textbook in 1961, the first edition of God, the Archetype Pattern of the Universe. This was also 13 years after the swearing in of President J. F. Kennedy to the office of President on January 20, 1961. Kennedy was the last President to Retire (DIE) in office. Thus,

37 = President Nixon, 37th President of the United States
 + 13 = Number of years from 1961 when our Textbook was published to 1974 when President Nixon resigned
 50 = Pentecost, the Law required the High Priest to Retire at age 50

Thus President Nixon RESIGNED OR RETIRED from the office of President "right on time". No Carnal Minded Historian (I Cor. 2:14) has been able to explain WHY Nixon Resigned, why he was Exposed in the Watergate cover up, and what this all Ultimately pointed to.

President Nixon made preparations for the 1976 United States Bi-Centennial (200 years from 1776) Anniversary, a Type

of Jubilee. His resignation from office prevented him from celebrating the Bi-Centennial Anniversary as President. This is just a REFLECT of Yahshua the Messiah not celebrating Jubilee in the Flesh with his disciples because he was Crucified, Buried, Resurrected, Ascended, and He Poured Out His Spirit on the Day of Pentecost, June 6, A.D. 33, (the Year of Jubilee) which is the Reality of Jubilee (Isa. 61:1, Lev. 25:8-16). Our Founder took off the flesh on February 9, 1976 which was before July 4, 1976, the Bi-Centennial Anniversary (Fourth Jubilee, 4 X 50) of this country. In March, 1976, this school (The Institute of Divine Metaphysical Research, Inc.) began the Third (3rd) and Last Ecclesiastical Peace Mission by expounding this Gospel to the Political and Religious Heads of 16 countries throughout the world (See Text, Vol. I, p. 3).

As stated throughout this paper, the Presidents that were Elected during the Twenty (20) Year Election Cycle starting from 1840 are a REFLECT of the Levitical High Priest RETIRING FROM OFFICE AFTER TWENTY (20) YEARS OF SERVICE. (They began at age 30 and retired at age 50). There are a total of Seven (7) Presidents that have already Retired (DIED) in Office that were Elected during the Twenty (20) year Election Cycle. Will President Reagan (40th) be the Eighth (8th) to Retire in office??? Since President Reagan (40th) was Elected in 1980, the Last Twenty (20) Year Election Cycle in Time or this Age, he MUST be NOMINATED and RE-ELECTED again to the office of President so that He can RETIRE (DIE) in Office, for this is according to Yahweh's Purpose, Pattern and Plan.

Ronald Reagan was Elected by the voters on November 4, 1980 with a surprising and spectacular margin over the incumbent President Jimmy Carter (39th President). The Reagan landslide was, in part, attributed to crossover (Passover) voting by disaffected Democrats. The Republicans gained control of the Senate for the first time in 26 years, and they picked up 33 seats in the U.S. House of Representatives. Reagan won 44 states with 489 Electoral Votes and received 43,899,248 popular votes - 51 percent of the Ballots cast. Carter won 6 states and the District of Columbia with 49 Electoral Votes and received 35,481,435 popular votes - 41 percent. The Independent Candidate John B. Anderson received 5,719,437 votes - 7 percent of the popular vote.

Ronald Reagan's 489 Electoral Votes (rounding up to 490) correlates, in type, with the 70 weeks of Daniel's Prophecy (Dan. 9:24) or 490 year cycle (or 49, zeroes have no value) in which Yahweh Dedicates His Temple (John 2:18-21; Acts 2:1-4; I Cor. 6:19-20) and RETIRED (Matt. 5:17-18) CARNAL ORDINANCES (Heb. 9:10; Rom. 10:4; Col. 2:14-18) and the LEVITICAL (AARON-ITE) PRIESTHOOD (Heb. 7:11-28), by Yahshua the Messiah's Death, Burial, Resurrection, Ascension and the Outpouring of the Holy Spirit. Yahshua the Messiah Dedicated the Spiritual Temple (Acts 2:1-4) 490 years after Artaxeres gave the Commandment to Rebuild Jerusalem in 457 B.Y. (Before Yahshua) plus 33 years of the Messiah's life (457 B.Y. + 33 years = 490 years) which is the complete Fulfillment of this Prophecy. The 51 percent of the popular votes Ronald Reagan received

correlates, in type, with Pentecost (50) when the Holy Spirit was poured out on the Jews in Jerusalem June 6, A.D. 33½ and Seven Years later on the Gentiles in A.D. 40½, which is our Victory over Satan and his Host through Yahshua the Messiah. The 44 states Reagan Won (or his Victory in the Election) is correlated, in type, with the Victory (Isa. 25:8; Psa. 98:1; I Cor. 15:54-57; Ex. 15:1-13, 17-21; Rev. 15:1-3) over Pharaoh and his Host that Joshua the Son of Nun and the Children of Israel Won by coming through the Divided Waters of the Red Sea after Slaying the Paschal Lamb and following a Cloud that was a Pillar of Fire by Night and a Cloud by Day (Ex. 13:21-22), 430 years (or 43, zeros have no value) after the Abrahamic Promise. Their 40 years journey in the Wilderness (Holy Place by the Pattern, Ex. 3:5) following this Cloud (Ex. 40:36-38; Num. 9:15-23) is likened unto One Day (II Pet. 3:8) or being in the Spirit. Thus,

430 years = Time from Abrahamic Promise to Joshua the Son of Nun and the Children of Israel coming through the Red Sea (I Cor. 10:1-4)
+10 = 1, typified the 1 Day in the Wilderness or being in the Spirit (Deut. 2:7; Ex. 13:21-22, 40:37-38; Matt. 27:51-53; Rev. 20:6, II Pet. 3:8; 1 Day = 1000 years)
 440 years = 44 states Reagan won. In Principle, Time from the Abrahamic Promise to the Israelites dwelling 40 years in the Wilderness (Holy Place) in the DAY, after their VICTORY over Death, Hell and the Grave (Egypt) by the Slaying of the Paschal Lamb (Ex. 12:1-13, 21-24; Rev. 12:7-11; 13:8).

President Reagan, after his Election, did lead the nations back from a severe Depression as a Reflect of Yahweh, by the Hand of Moses, leading the Children of Israel out of Egypt into a land flowing with milk and honey. We see how President

Reagan was Elected in accordance to the Purpose, Pattern and Plan of Yahweh.

President Jimmy Carter's Defeat by Ronald Reagan also Reflects the Purpose, Pattern and Plan of Yahweh. The Six (6) States Carter won correlates, in Type, with the Sixth (6th) Step in the Tabernacle Pattern which is the Second (2nd) Vail that divides the Most Holy Place from the Holy Place (also called the Vail of the Flesh, Heb. 10:19-20; Matt. 27:51-53; II Cor. 3:13-16). This Vail was Rent from Top to Bottom in the Herodian Temple after Yahshua the Messiah Resurrected and the Graves were opened (Matt. 27:51-53; Heb. 10:19-20; II Cor. 3:16), just as the River Jordan (Sixth Step in the Migratory Pattern) Divided (Josh. 3rd Chapter) after the Children of Israel mourned Moses' Death for 30 days and Joshua Son of Nun gave the Israelites 3 days to prepare victuals (a total of 30 days + 3 days = 33 days/years, Num. 14:34, 1 day = 1 year, Deut. 34:8; Josh. 1:11, compare with Rev. 16:12). Thus, as a Reflect of the Graves being opened and the Captives being Released (Matt. 27:51-53), we have the Release of 52 American Citizens January 20, 1981 after 442 days or since November 4, 1979. They were held hostage by the revolutionary government of Iran headed by Ayatollah Ruhollah Khomeini. Now the 49 Electoral Votes President Carter won correlates, in type, by the Pattern with the Herodian Temple being 49 years (46 years in the building in A.D. 30 + 3 years Yahshua the Messiah was in his ministry) in the building when Yahshua the Messiah (Matt. 5:17-18; Heb. 7:11-22; Rom. 10:4; Col. 2:14) was

Crucified, Buried, Resurrected, Ascended and Poured Out His Spirit on the Day of Pentecost. This Dedicated the Spiritual Temple (I Cor. 6:19-20; Acts 2:1-4), which Released the Sons from the Bondage of the Devil or Death, Hell and the Grave (I Cor. 15:53-57). Thus, we see how President Carter Retired from office after aiding in the Release of the 52 American Hostages in Iran by the Pattern.

President Reagan will be RE-ELECTED for another very significant reason which is according to the Purpose and Plan of Yahweh. All of the Presidents and Vice-Presidents have been MALES because the High Priest and Low Priest (Num. 4:2-3, 16, 22-33, 29-30) under the Mosaic Law were ALL MALES BEING A TYPE POINTING TO YAHSHUA THE MESSIAH (THE TRUE AND ONLY MAN, Matt. 20:28). We are the Bride (Eph. 5:23-32; Rom. 7:1-4; I Cor. 15:20-23; II Cor. 11:2). Thus the Ploy that Mondale, the Democratic Presidential candidate, used in CHOOSING A WOMAN as Vice-President to Get Votes to Win the Election Will Not Work. Since the Vice-President is a type of the Low Priest, who was always MALE under the Law, it is IMPOSSIBLE for Walter Mondale and Geraldine A. Ferraro (the first female, who is also a Roman Catholic, age 49), Vice-Presidential Candidate, to be Elected because it would be out of Harmony with the Purpose of Yahweh (Isa. 46:9-10). Thus again, we state that President Ronald Reagan (40th President) will be NOMINATED by the Republican Party at the 33rd Republican Convention, RE-ELECTED (Nov. 6, 1984) to the 49th Presidential Term (since George Washington's first term in 1789) with Vice-President

Bush (43rd Vice-President), and will RETIRE (DIE) in Office,
i.e. HE WILL NOT COMPLETE his Second Term for this is
according to the Purpose, Pattern and Plan of Yahweh.

Now let us proceed to present Sufficient, Ontological
Proof (I Thess. 5:21), Evidence and Facts (as any Lawyer of
Jurisprudence (Rom. 7:1) does in a Court of Law) in accordance
to the Divine Pattern of the Tabernacle and the Purpose and
Plan of Yahweh that will show forth the PROPHECY OF PRESIDENT
REAGAN (40th) RETIREMENT POSSIBILITIES (Death, Resignation,
etc.) IN OFFICE is TRUE. Now many Soothsayers (I Cor. 2:14;
Dan. 2:27-30; Isa. 47:13), Seers, Fortune Tellers and
Prognosticators have prophesied that President Reagan will not
finish his Second Term, but THEY CANNOT PROVE or CORROBORATE
IT because they have NO PATTERN and KNOW ABSOLUTELY NOTHING
ABOUT THE PURPOSE AND PLAN OF YAHWEH in accordance to the Law
and Prophets (Isa. 8:20). The Last President to RETIRE (Die)
in office was President J. F. Kennedy (35th) who was
Assassinated. Now Ronald Reagan is the 40th President Elected
in 1980, the Last 20 year Election Cycle in this Age (or shall
I say IN TIME). The following calculations are presented on
the next page:

- 35 = President Kennedy, the 35th and LAST President to Retire (DIE) in office elected in 1960
- + 40 = President Reagan, 40th President, Elected in 1980
- 75 = the total of the two president's numbers. There are a total of Seventy-Five (75) Twenty (20) year Terms (reigns) of the High Priests under the Law or from 1490 B.Y. (Giving of the Law at Mt. Sinai) to the Birth of Yahshua the Messiah who came to fulfill (Matt. 5:17-18; Lk. 24:44-45) Carnal Ordinances and RETIRE the Levitical Priesthood (Heb. 7:11-18, 9:10). The Seventy-Five (75) Terms of Twenty (20) year reigns of High Priests is as far as Yahweh is concerned, even though there were periods in the Israelites' History where there were No High Priest, such as the 70 years of captivity in Babylon. (20 years High Priest Reigned divided into 1490 years until the Birth of the Messiah = $74\frac{1}{2}$ or 75 for calculation purposes; 75 terms X 20 years = 1500 years)
- + 23 = number of years from 1961 A.D. when President Kennedy was sworn into office January 20, 1961, and our Textbook was published October, 1961 to the 1984 Presidential Election November 6, 1984
- 98 = 2 X 49 years, Will Reagan be the Last Elected President???
- + 2 = Number added to get to Pentecost (Death, Assassination, Impeachment, etc.)
- 100 = 2 Pentecosts (50), Will President Reagan Retire in office???

NOTE: The Statue of Liberty (The Lady) was Renovated and Her Lamp (Light, Rev. 2:5; John 8:12) was REMOVED after standing at Harbor Gate as a Beacon to the Many Immigrates 98 years or 2 X 49 Years (See Exhibit 8). The recent Congressional Bill limiting the number of Immigrants into this country (New World) is being reflected by the Lady's Light being put out, i.e. We are at the END of the Probationary Period and the Harvest (or the Body) is complete.

The 23 years from 1961 to 1984 (the Presidential Election year) must be added ($23 + 75 = 98$) to the total of the two Presidents, Kennedy (35th) and Reagan (40th, $40 + 35 = 75$) because 1961 was when President Kennedy the Last President to Retire (DIE) took office, after being Elected in the November 1960 Election and our Textbook was published in 1961 (first edition)

that judged Mystery, Babylon the Great, Mother of Harlots and Abomination of the Earth. The sum of 23 years and 75 ($23 + 75 = 98$) is 98 which is 2×49 year cycles which gets you to the Presidential election in 1984. Adding 2 years to 98 ($98 + 2 = 100$) to get to Pentecost (2×50) would be 1986. (NOTE: President Reagan will be 75 years old in 1986.) Will Ronald Reagan Retire (Die, Be Impeached, Assassinated, Resign, etc.) from office???

When the President is sworn into office on January 21, 1985 this will be the 49th Four-Year Presidential Term starting from April 30, 1789 when President George Washington (1st President) was sworn into office. NOTE: $1789 + 196$ years = 1985; $4 \text{ years} \times 49 \text{ Presidential Terms} = 196$ years. This 49th Presidential Term is correlated with the Herodian Temple being 49 years in the building when the Messiah was Crucified (John 2:18-21) which RETIRED and FULFILLED (Matt. 5:17-18; Lk. 24:44-46; John 19:30) the Aaronite or Levitical Priesthood (Heb. 7:11-22). Thus, there ABSOLUTELY MUST BE A REFLECT in this next Presidential Term of the President RETIRING (DYING) in office for this is in accordance to the Purpose of Yahweh.

We in this Teaching know that all events operate by the Tabernacle Pattern. Now President Reagan being the 40th President correlates with the 40 years the Children of Israel were in the Wilderness under the leadership of Moses after Moses received his Commission at the Burning Bush (Exo. 3rd Chapter). The Children of Israel Resurrected in the Wilderness of Sinai (Holy Place by the Pattern, Exo. 3:5) from Egypt

(Court Round About) by placing the BLOOD OF THE PASCHAL LAMB on the two side posts of the doors and the lintel of the door from a basin (4 points of Blood, Exo. 12:1-22), by going through the divided WATERS of the Red Sea (I Cor. 10:1-4) and by following the Cloud which was SPIRIT (Exo. 13:21-23; Num. 9:15-23). Remember the Children of Israel and Joshua the Son of Nun came through the Red Sea 430 years after the Promise to Abraham. (Joshua being in Egypt 30 years, was fulfilled by the Messiah being baptized in the River Jordan at 30 years of age, Lk. 3:23). It is no coincidence that George Bush (typifying Joshua the Son of Nun in the Burning Bush - Exo. 3:1-4) is the 43rd Vice-President (For details on the 430 years or 4030 years or 43 years Principle see the Red Book The Third World War, pp. 6, second paragraph through p. 8). Now Moses being a TYPE of the High Priest in the Greater and More Perfect Tabernacle, the Migratory Trek, spent 40 years in the Wilderness being the Mediator (I Tim. 2:5) between Yahweh and the People of Israel, just as President Reagan finished his First Four-Year Term Leading and Guiding this nation. The next STEP in the Migratory Trek is the River Jordan that divides the Wilderness of Sinai from Canaan Land or the Second Vail (or 6th Step) of the Tabernacle that divides the Most Holy Place from the Holy Place. After Moses gave charge to Joshua the Son of Nun (Yahweh-Elohim in a Physical Body, see 24th Chapter of Joshua) Moses Retired (DIED), and Joshua and Israel Mourned Moses' Death 30 days (Deut. 34:8); then Joshua gave the Israelites 3 Days (Josh. 1:11) to prepare victuals (a

total of 33 days) Before they crossed the River Jordan (Josh. 3:1-17). Now the River Jordan represents the Second Vail in the Pattern or the 6th Step in the Tabernacle Pattern which is called the Vail of the Flesh (Matt. 27:51-53; Heb. 10:19-20; II Cor. 3:16, Rev. 16:12). We see that President Reagan is the 40th President and that he led the country 4 years (4 + 4 = 8, zeros are deleted since they have no value), just as Moses had spent a total of 80 years in the Wilderness (40 years keeping his Father-in-law's sheep and 40 years with the Children of Israel) before he Retired (Deut. 34:1-8). President Reagan's next step is the 2nd Vail or the 6th Step (Nominated at the 33rd Republican Convention), and HE MUST RETIRE as Moses RETIRED (Died; see Vol. I, Arrow 6 Compared to Arrow 6A, p. 82-85) and John the Baptist (John 3:22-30) RETIRED (Died) "on time" in accordance with the Tabernacle Pattern. It was Joshua the Son of Nun (a type of Yahshua the Messiah), that led the Israelites across the River Jordan (Josh. 3:1-17; Matt. 27:51-53; Heb. 10:19-20; Rev. 16:12), and they Fought with Gentiles 40 years in Canaan Land Before they were put into subjection to Joshua (Josh. 12th and 24th Chapters) and the Israelites. When Vice-President Bush (typifying the Angel in the Burning Bush, Exo. 3:1-5) is given Charge (or the Presidency, Deut. 34:9), Will He Lead the Nation and the World into a 'Universal Catastrophe' by trying to put the Gentiles (Atheistic and Materialistic Russian Kremlin) in Subjection???

"Where is the wise? Where is the scribe? Where is the disputer of this Age? Hath not Yahweh made foolish the wisdom of this Age?" (I Cor. 1:20)

No matter how the Facts are presented in comparing President Reagan (40th) with President Nixon (37th) who Resigned (Retired) from office or President Kennedy (35th) who Died or was Assassinated (Retired) in office, President Reagan (40th) must RETIRE (Die) in office, for this is according to the Purpose, Plan and Pattern of Yahweh.

President Reagan's Second Term beginning in January, 1985, and the Constitution, the Foundation Stone of the United States (Eph. 2:19-21), were set up as Physical REFLECTS of the Purpose, Pattern and Plan of Yahweh. The Constitution was Ratified June 21, 1788 (for calculation purposes round up to 1789) and President George Washington was sworn in office on April 30, 1789 as the First President of the United States under the Constitution. The United States (both North and South America) is often referred to as the NEW WORLD when comparing this country to Europe, the OLD world. As everyone knows, nothing continues to exist on the Earth Plane without an END. The question that naturally arises is, How long will the Constitution continue in Existence Before there is an Manifestation of an END or NEW ORDER (NOVUS ORDO)? No Carnal Minded Historian can even ponder this question except by idle speculation because they know ABSOLUTELY NOTHING of the Purpose and Plan of Yahweh which REPEATS itself over and over again. To End The Debt Crisis

WASHINGTON — The leaders of the world financial community will gather here next week for the annual meetings of the International Monetary Fund and the World Bank. They have good reason to congratulate themselves for skillfully managing the third world debt crisis by redesigning the global credit system. But more still needs to be done before the crisis is truly behind us.

It is often said that the crisis was dealt with in a reactive, ad hoc fashion. True, grand schemes to restructure or cancel some \$800 billion in developing countries' debts have been rejected. Nevertheless, a series of incremental reforms has dramatically transformed the world of finance in the last two years — most importantly by increasing the power of public sector financial institutions.

First, the International Monetary Fund has become much more powerful. The number of Latin American and African countries being guided by I.M.F. stabilization programs has ballooned, and the fund has compelled a great number of commercial banks to make loans under its umbrella.

Second, debt reschedulings — once reserved for isolated, special cases — have become the norm. In the last two years, official creditors and

banks have rescheduled more than \$100 billion in loans owed by dozens of nations and have recently agreed to a long-term restructuring of much of Mexico's outstanding debt.

Third, developing countries have been integrated into two important emergency credit mechanisms. Developing countries now have access to the "General Arrangements to Borrow" fund that supplements I.M.F. lending. Meanwhile, the Federal Reserve Board and the Treasury Department have extended short-term lines of credit to several debtor nations, including Brazil and Argentina.

Fourth, national regulators in the United States and other industrial nations have significantly tightened their supervision of international lending.

Fifth, banks have been forced to question the old verities — for example, the view that "countries don't go bankrupt" — that led to lax lending practices. Banks have also improved their ability to gather and analyze information and are paying more atten-

tion now to economists and country-risk specialists.

Despite these innovations, however, problems remain. The most serious is that many third world nations have become net exporters of capital to the international credit markets. In 1983, non-oil exporting developing countries were obliged to pay an estimated \$50 billion in interest to private creditors, while receiving only about \$20 billion in new loans. The resulting "financial flow gap" of \$30 billion exceeded by some \$15 billion the net transfers by the World Bank and the I.M.F. to the third world. If interest rates remain high and new bank loans are scarce, this

hemorrhaging of badly needed capital can only get worse.

This perverse transfer of money from the poor must gradually be reduced. The problem can be attacked from both ends: by cutting interest payments and increasing new lending. The problem is that there will be no substantial decline in interest rates until the United States comes up with a credible plan to reduce its budget deficit.

Capital flows to the developing countries should be increased by augmenting the resources of the World Bank and the I.M.F. These agencies also need to find new ways to encourage bank loans and direct investment. Official trade promotion agencies, such as the United States Export-Import Bank, should also increase their own lending and their guarantees of private trade credits.

To gain access to these loans, developing countries will need to improve their creditworthiness. Many debtor nations have already slashed Government spending and cut wages in order to reduce imports and improve their balance of payments. Now their task is to move beyond economic stabilization and austerity to the creation of new industries and jobs, especially in the export sector.

The unfinished agenda is clearly formidable. It is not yet time for the world's financial leaders to break out the champagne. □

Money at Risk Financial Institutions Are Showing the Strain Of A Decade of Turmoil High Interest Rates, Easing Of Inflation, Bad Loans Hurt Banks, Other Firms But System Proves Resilient

A decade of turmoil in the financial-services industry is taking its toll. Cracks are appearing, and they may be only the beginning.

Just weeks after fashioning a multibillion-dollar rescue for Continental Illinois Corp., one of the nation's largest banking concerns, government officials helped oust the management at deeply troubled Financial Corp. of America, the nation's largest thrift organization. Meanwhile, bank failures total 54 so far this year—already exceeding the post-Depression record of 48 for an entire year.

The strains stem from high and unpredictable interest rates, a sudden end to steep inflation, and deregulation. They have been exacerbated by merger mania, reckless lending and a proliferation of new financial products. Moreover, the strains aren't limited to depository institutions; they cut across the entire financial-services industry and are causing a steady procession of financial scares in one business after another. Many big brokerage firms are posting record deficits, and property-casualty insurers are reeling from underwriting losses.

Worried Executives

"You've got a financial system that is in a state of disrepair," says Thomas F. Donovan, senior executive vice president of Marine Midland Bank. Adds the head of one of the nation's largest banks: "I get up every morning and worry about what could go wrong."

Nobody knows where this turmoil will lead. At the least, analysts expect more mergers and forced liquidations. For investors in the troubled institutions, that could mean big losses. For employees in those institutions, it could mean layoffs. Last month, for example, A.G. Becker Paribas, an investment bank, was taken over by Merrill Lynch & Co. after Becker suffered huge bond-market losses. Hundreds of Becker employees are out of jobs.

Further strains also could weigh heavily on American taxpayers. Although the government doesn't fund deposit insurance, some financial-industry analysts believe that protection against major financial losses—whether for customers of banks, brokerage firms, insurance companies or thrifts—ultimately will be borne largely by the government. But the government's resources are strained; widespread bailouts may force it to either raise taxes or print money to aid failing institutions and the latter course could reignite inflation.

Shakeout Forecast

"We've created an entirely new system in the last 10 years," says Joseph Flom, a takeover attorney. "There's going to be a shakeout."

The procession of jumbo-sized financial scares has been jarring. In 1980, Bache Group Inc., a big securities firm, and some of its lenders teetered on the brink of collapse because of huge loans to the Hunt brothers, whose enormous investments in silver were plunging in value. In 1982, Drysdale Government Securities Inc. went bust, costing Chase Manhattan Bank more than \$135 million and nearly hobbling a slew of securities firms. That same year, Penn Square Bank of Oklahoma City failed, sending shockwaves through the banking system. In 1983, Baldwin-United Corp., an insurance and financial-services conglomerate, filed for protection against its creditors, and earlier this year, Charter Co., a similar concern, took the same course. And this summer, Continental's deterioration led to the federal government's largest intervention.

Such a list worries Washington, where later this month the House Banking Committee will hold hearings on Continental's near-collapse. The committee also will probably consider the overall weakness in the financial system. Rep. Ferdinand St Germain, the committee's chairman, said in a recent interview that the financial system is at a "crossroads." The Rhode Island Democrat added that Congress should decide what the government should do when "a large financial institution gets into trouble."

Gone Too Far?

In addition, the House is expected to take up legislation that would push certain nonfinancial companies, such as J.C. Penney Co. and Sears, Roebuck & Co., out of the deposit-taking business. Part of the impetus for the legislation is a growing consensus that the recent growth and diversification among financial-services companies have gone too far.

For all the turmoil, the financial system has shown impressive resiliency. So far, private-sector ingenuity and government intervention have prevented individual disasters from spreading. Referring to the Continental rescue, Mr. Flom notes, "If a bank that size had gotten into trouble in the pre-Roosevelt era, it would have been a national calamity." Federal Deposit Insurance Corp. officials add that crisis-management skills are improving with each banking disaster.

Yet most analysts predict that the system will continue to be severely tested. Much of the strain will be psychological; financial-services-industry participants say that until recently, the response to crises has been to see them as isolated ailments that could be contained. But they say that has changed, largely because of the interna-

tional debt crisis and Continental's brush with disaster. Now, they discern an unspoken fear that the whole system is shaky.

The fact that problems are occurring all at once all across the financial-services industry brings an added level of risk. Because financial institutions are becoming more interdependent, problems are increasingly likely to migrate from one concern to another. For example, Baldwin-United's travails led to an \$83 million after-tax charge last year at Merrill Lynch, which, in its push to diversify, had been selling Baldwin's annuities.

Elsewhere, banks are selling loan participations to other banks more frequently. Thus, Penn Square's reckless lending not only brought that bank down but also led to the merger of Seafirst Bank into BankAmerica Corp. and contributed to Continental's near-collapse two years later. Both banks had purchased loans from Penn Square.

A House economist in Washington worries that "all of these institutions meet every day in the government-securities market," which has proved treacherous at times. The Drysdale Government Securities failure threatened to weaken more than a dozen other dealers until Chase Manhattan Bank agreed to honor the defunct firm's obligations.

The strain also comes from basic economic forces. Ironically, one of those is the halt in high inflation, which the Reagan administration cites as its crowning economic achievement. Continental's troubles stemmed largely from energy, real-estate and foreign loans made on the widely held but mistaken assumption that inflation would rage on unabated. When it didn't, loans extended by Continental, and by others operating on the same assumptions, began to sour.

High inflation also encouraged financial companies to borrow heavily for expansion. Baldwin-United borrowed about \$1 billion to acquire a big mortgage insurer, MGIC Investment Corp.; in doing so, Baldwin-United took on a debt burden that ultimately helped sink it.

Optimists interpret the current turmoil as a painful adjustment to new economic conditions rather than as a lasting malaise. "What you're seeing is the beginnings of a cure," in which companies "are doing things to disgorge the excesses of the past," says George Ball, the chief executive officer of Prudential-Bache Securities Inc. Under high inflation, he explains, financial institutions could paper over bad credit risks. "Now, the climate is such that management mistakes have been coughed up into the light of day."

Deregulation's Effects

Also painful to financial businesses has been the deregulation drive. In the securities industry, Congress ended the fixed-commission system that had protected the income streams of brokerage firms.

Most important has been the congressional deregulation of interest rates, combined with the Fed's October 1979 decision to allow rates to fluctuate more and a resulting, unprecedented volatility in rates. In addition, rates may be permanently higher.

Henry Kaufman, the chief economist at Salomon Brothers Inc., believes that "financial deregulation has contributed to a higher structure of interest rates," so that rates remain high even though inflation has subsided.

For thrift institutions, carrying older, low-yielding mortgages, the new rate structure has been devastating. The lofty rates have eaten into capital and forced hundreds of savings institutions into government-assisted mergers.

Federal regulators also have allowed financial companies to invade one another's turf. For example, in 1981, the Federal Reserve Board and the comptroller of the currency permitted hundreds of banks to offer discount brokerage services. That new competition is aggravating the strains being felt by Merrill Lynch and other full-service brokerage firms.

Too Much Change

One result of all this is simply that many institutions, and regulators, are suffering from an overdose of change. "The whole system has to stabilize," says Dennis Jacobs, an economist for the U.S. League of Savings Institutions. "Now, it's disequilibrium."

The ways that managers have responded to the shocks have often made things worse. "All of these businesses are overcrowded—banking, securities, insurance," says Barbara Stewart, the president of Stewart Economics, a consulting firm. "You see banks reaching for riskier and riskier loans. In insurance, companies are taking lower and lower premiums for riskier types of insurance."

Swift growth and big-dollar bets on the direction of interest rates largely account for the problems at Financial Corp., which ballooned to assets of \$32.7 billion on June 30 from only \$6.6 billion at the end of 1982. American Express, after an orgy of takeovers in securities and banking, was blindsided when its insurance unit, Fireman's Fund Insurance Co., had to jack up its loss reserves by \$230 million.

Big financial conglomerates "are only capable of managing so many dollars of assets effectively," says Perrin Long, a financial-industry analyst with Lipper Analytical Distributors Inc. Or, as Salomon's Mr. Kaufman says, financial institutions are "larger but weaker."

Here is how the strains are affecting the four main financial groupings.

Banking

One sign that banks are experiencing systemic troubles is the stock of J.P. Morgan & Co. Known as the bluest chip in banking, Morgan stock nevertheless sells at only about six times earnings, well below the price-earnings ratio for many lackluster industrial companies.

On the lending side, the loans that many banks have made to cash-strapped developing nations and energy companies have turned sour at alarming levels. For banks with more than \$10 billion in assets, the ratio of nonperforming assets to total loans and real estate more than doubled between 1980 and 1983. And this doesn't include most of the troubled loans to foreign governments,

which regulators generally still allow banks to carry on the books at 100 cents on the dollar.

Banks have accepted riskier loans partly because their safest corporate customers have taken to raising cash by selling commercial paper—short-term corporate IOUs—through investment banks. "You've got more and more banks chasing less-quality types of borrowers," Marine Midland's Mr. Donovan says. "If banks lose sight of quality (controls), they can fill their portfolios with garbage."

In addition to taking on new and often-riskier customers, such as Third World borrowers, banks have extended novel and sometimes riskier credits, such as leveraged buyouts, guaranteed letters of credit for securities offerings, and interest-rate swaps.

Risks also have risen on the deposit side of the balance sheet. Banks have increasingly funded their operations by attracting large, uninsured deposits from nervous institutional investors around the world. As Continental's case demonstrated, financial problems can lead to a lethal run by panicky money managers.

Meanwhile, the FDIC has made some big depositors even more nervous by placing uninsured depositors at risk in the failures of small banks. But the Continental rescue, in which depositors of all sizes were guaranteed, has increased the confusion.

Given all these uncertainties, banks' capital levels are generally viewed as too low. "We've moved to financial deregulation at a moment when many financial institutions have a thinness of capital and a problem with the quality of assets," Mr. Kaufman says.

Federal regulators have proposed tougher standards that would raise to 6% the ratio of a bank's total capital to assets, and Fed officials hint that this would be only a first step. Some analysts say that despite efforts in Washington to impose stiffer capital requirements, banks are still let off too easily by being allowed to include loan-loss reserves as part of capital.

A continued economic recovery, particularly if coupled with lower interest rates, would surely help the banks. But regulators are surprised that banks haven't benefited already. FDIC chief William Isaac says that by historical standards, bank failures should have tailed off beginning in June, 18 months after the recovery began. They didn't.

Thrift Institutions

After weathering an industry crisis two years ago, in which 1,100 troubled thrifts disappeared through mergers or reorganizations, savings institutions are again strapped. Stubbornly high interest rates, plus the threat of further increases, are the chief culprit. The problems of Financial Corp. stem partly from mistaken bets on which way rates would go this summer.

Says the chairman of another California thrift institution, "For the record, the industry is in tough shape. Off the record, it's a disaster."

Although lifting the ceiling on interest rates was initially billed as a competitive aid to thrifts, it has hurt in many ways. The

institutions are paying higher interest on deposits, but they still are saddled with billions of dollars in older, low-rate mortgages. By some counts, four of 10 thrifts have lost money in every quarter since 1982. Industry economists say that because of eroded capital structures, the thrifts are less able to withstand losses than they were two years ago.

The Federal Home Loan Bank Board has tried to jawbone thrifts into issuing mainly adjustable-rate mortgages, which, in effect, shift the risk of interest-rate increases to borrowers. Adjustable mortgages extended this year should total \$172 billion, Salomon Brothers estimates. But as rates rise, homeowners will have difficulty meeting the higher mortgage payments, and foreclosures could skyrocket.

Diversification has also proved a mixed blessing for the thrifts. Legislation passed in 1982 empowers them to expand beyond mortgages into certain forms of commercial real-estate lending. But these new ventures can be much riskier, particularly for the uninitiated. George Davis, executive vice president of First National Bank of Chicago, says some thrifts are writing commercial mortgages "at rates we think are obscene and with structures that are risky. We think they are buying trouble."

That was certainly the case for Empire Savings & Loan Association of Mesquite, Texas, which collapsed last March in the largest thrift failure to date, after pouring money into construction projects outside Dallas. When the projects failed, so did Empire.

The FDIC's Mr. Isaac says the thrift industry's afflictions can be summed up in two words: "high rates." Indeed, Financial Corp.'s future may depend on the level of rates the rest of this year. Jonathan Gray, an analyst at Sanford C. Bernstein & Co., believes that 84% of Financial Corp.'s deposits will mature within a year, and that if rates rise in the meantime, it may have to pay more to hang on to these deposits. But Financial Corp. can't replace its assets because only about 30% of its loans and investments mature within a year.

Insurers

Like other financial sectors, the insurance industry is plagued by tougher competition and thinner margins.

But unlike the banking and securities industries, the insurers don't have any federal or industry-supported overall safety net; instead, policyholders are protected by a hodgepodge of state regulations and guaranty funds that critics term inadequate. Baldwin-United annuity holders are hoping that the insurance and securities industries will make up part of the annuity holders' lost interest.

For property-casualty insurers, which cover everything from automobiles to product liability, business is "far riskier than ever," says John Cox, executive vice president and head of financial services at American Can Co. More than half of the insurance premiums currently are for casualty and liability risks, on which claims often don't come in for years and insurers get to keep

the premium dollars longer for investment.

These days, however, both the investments and the claims are less predictable. Large settlements over product defects and workplace illnesses have hit insurers hard. Meanwhile, many corporations have been self-insuring the safest, most predictable risks.

High interest rates have exacerbated the boom-and-bust cycle of property-casualty insurers. Record interest rates "mesmerized people inside the industry and outside who believed the business was a cash cow," says M.R. Greenberg, the chief executive of American International Group Inc., a large insurer. People thought that "all you had to do was collect premiums, and investment income would take care of all claims losses," he says.

But the result was a drastic price war, Mr. Greenberg says, with rates on many insurance lines plummeting 40% to 60%. Eventually, investment income couldn't compensate for that.

Now, claims losses are soaring; some big insurers, including Cigna and St. Paul Cos., reported second-quarter losses. And analysts believe that many companies' loss reserves aren't adequate.

However, the two biggest failures have been companies operating in the once-staid life-insurance industry. Baldwin-United and Charter grew too rapidly. Their growth was fueled by skyrocketing sales of the single-premium deferred annuity, which lets buyers build up tax-deferred income.

Experts say neither company understood the risks in the annuity product, particularly given volatile interest rates. Baldwin and Charter both wrote annuities that let buyers cash in their policies and get their money back without penalty if the rates paid on their policies dropped more than a percentage point or two. Amid the general decline in interest rates from their peaks during the Carter-administration years, Baldwin tried to dissuade people from cashing in their policies; it did so by keeping its policy rates artificially high—but at too high a cost to itself. Charter, in contrast, allowed some policyholders to cash in. Because so much money had earlier flowed into the two companies, a total of \$7 billion, both were highly leveraged and thus highly vulnerable.

Securities Firms

After a decade of mergers and diversification, Wall Street is finding that bigness and diversity, once viewed as a panacea for the stock market's ups and downs, have drawbacks. Merrill Lynch, the biggest securities firm and long a pacesetter, is shrinking after having expanded to 44,000 employees and hundreds of different financial products—and after a second-quarter loss of \$32 million.

The cost of furnishing brokers with computer support and training in new products has ballooned securities firms' expenses. E.F. Hutton & Co. spends \$46,000 a year on each broker, before paying any commissions.

Jeffrey Schaefer, an economist for the Securities Industry Association, says that trading volume of 90 million shares a day on the New York Stock Exchange is needed for the large firms to break even. In the second quarter, trading averaged 86.7 million shares a day.

Securities firms also have been hurt by the volatile interest rates. The firms carry large bond portfolios, and many have sustained big losses when interest rates have swung about sharply.

Competition from the banks' discount

brokerage operations increases the pressure by making it difficult for the brokers to raise rates to cover the steeper expenses. "As they reach into one another's business, they erode each other's profits," Mr. Schaefer says.

One difficulty with diversification, Lipper's Mr. Long believes, is that it stretches management too thin. "The problem is that companies refuse to sell things," he says. For example, Sears Roebuck is faced with the disparate jobs of heading off further losses at Dean Witter Reynolds Inc., its Wall Street arm, while upgrading its image as a retailer of clothes and home products.

As an indication that diversification isn't necessary, Wall Street analysts cite Goldman Sachs, which has stuck to its core-customer base—financial institutions and corporations—but has grown nonetheless. It also has retained its partnership format despite the industry trend to raise capital by going public. Similarly, A.G. Edwards, a traditional brokerage firm, avoided the industry's vogue of expanding into insurance and offering an array of savings vehicles.

Yet, Mr. Long notes, both firms have profit margins well ahead of industry averages.

The devout, desperate wait for statue to cry for them

OUTSIDE THE CHURCH, an 11-year-old girl who said she is Presbyterian hawked photographs depicting the statue of the Virgin Mary to a crowd of Gypsies. She wrestled with the question of whether it was a sin to make money from what many Chicagoans think is a miracle.

Nohemi Preciado had stood alongside her father, Carlos, as they worked the crowds of the curious, the devout and the desperate who had come to see the statue shed tears at St. John of God Catholic Church, 1234 W. 52d St.

"We're not stealing anything," she said when her customers left without buying copies of the photograph that her father snapped with a borrowed camera. "My father is a photographer, and he lives from selling pictures. The priest told us we could do it. We need the money."

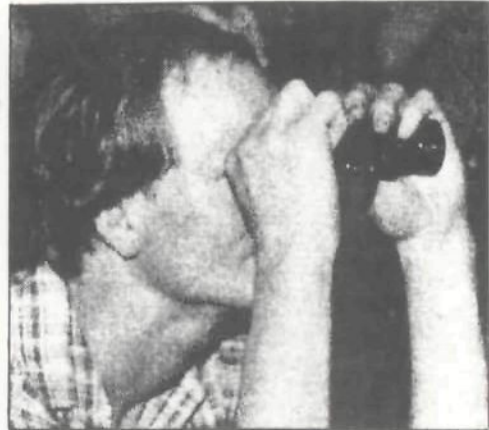
CARLOS BORROWED a cigarette, put on his dark glasses and spoke through his daughter, who interpreted his Spanish for him.

"Yes, the priest did say that," he said. "But last week, the first time we sold them, I couldn't sleep that night. Because of the fear that something could happen if I sold them."

The worshipers, mostly women and children, filed into the church as dusk fell. Some people stood outside on the steps and smoked. Others quickly turned their heads away from the handicapped who were being wheeled to the statue in hope of a cure.

Old men and women inched up the steps with their canes, or they rested heavily on the arms of their sons and daughters. They had rosaries in their hands and anticipation on their faces. Men waiting in parked cars sent their children into the church to retrieve their grandmothers.

"Tell Grandma it's been four hours already," one man said to his young son. "You

go in and get her now. She'll probably want to stay here all night."

IN POLISH, Spanish, Arabic and English, the people talked and huddled on the sidewalk, as they do in their own neighborhoods and as they would have done in the towns and villages where they were born.

"These people don't go to psychiatrists," said a woman from the West Lawn neighborhood on the Southwest Side. "They talk to their priests, to their hairdressers. They talk to their butchers at the stores. And they're here because they believe."

One visitor was Genevive Gerulis, who



grew up in the neighborhood. She teaches religious studies at Our Lady of the Ridge, Chicago Ridge, and took her two daughters with her to the church Wednesday evening. "People do need miracles and they need faith," Gerulis said. "Look at how many people have come here already since the tears. Sure people are curious, but at the same time you can look around you and see that they want to believe and that they do believe something powerful is happening here.

"I WILL NEVER be able to go to Lourdes or to Jerusalem. So I came here. This is my pilgrimage," she said.

Across the street in Sherman Park, an old man lay on his back near the handball courts and slept. He had been taken to the church by Jeff Bailey, a North Side real estate broker who had gone to the church every day and looked at the statue through binoculars.

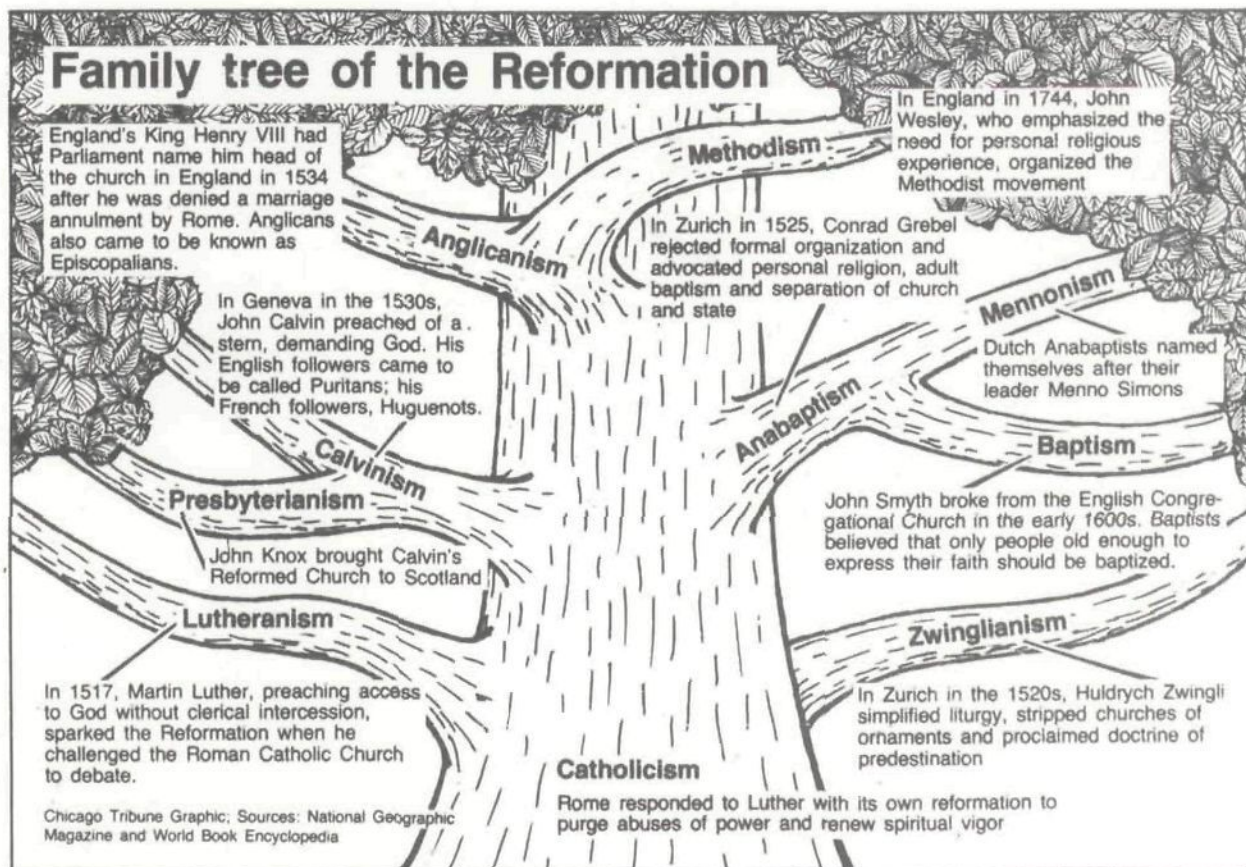
"I brought him with me today and I told him, 'You can either walk in or I'll carry you in; take your choice,'" Bailey said of the 65-year-old man he employs part time. "He thought I was kidding. But I wasn't. He didn't want to go in. But when he left, he was crying. . . ."

Bailey stood outside the church, looking across 52d Street at the man lying in the

grass while young boys smacked a softball in long arcs over his body. Night fell on the neighborhood. Ice cream vendors packed up their three-wheeled carts and put the dollar bills in their socks. The old ushers stood outside the church, talking about how good a cold one would taste as they let a 24-year-old gas meter reader, born a Baptist, straggle inside.

"I haven't been in a church for years, and never in a Catholic one," he said. "I'm here for a miracle. My wife's leaving me and taking my two kids with her. I'm the one who blew it. But I can't go through this life without my family. So that's why I'm here. I didn't come here to see her cry."

The Fateful Zero Cycle

President Kennedy's assassination has reinforced the superstition that presidents elected in a year ending in zero will die in office. This has happened every 20 years in more than a century.

The originator of the superstition was William Henry Harrison, the ninth president, who was elected in 1840. He had curvived in 1840. He had survived War of 1812. His victory over Tecumseh at the Battle of Tippecanoe was the basis for his campaign slogan, "Tippercanoe and Tyler too," John Tyler being the vice presidential candidate.

But Harrison lived only 31 days after his inauguration. He contracted pneumonia during the inauguration ceremonies on March 4, 1841, and died April 4, 1841. Modern medicine probably would have saved him.

TWENTY YEARS LATER President Abraham Lincoln was elected in a "zero" year, 1860. He survived his first term, was re-elected in 1864 and was assassinated April 14, 1865, by John Wilkes Booth. He died the following day. Recently there has been much speculation that modern methods of surgery, if they had been known at that time, could have saved his life.

Another 20 years passed and James A. Garfield was elected in 1880. On July

2, 1881, he was shot by a disgruntled office seeker, Charles J. Guiteau, in a Washington, D.C., railroad station. He died Sept. 19, 1881. For 79 days the United States virtually had no government. Garfield was still President, but unable to perform any functions of the office. His vice president, Chester A. Arthur, was reluctant to assume any of the duties of the President while the chief of state lay incapacitated, although some members of the cabinet urged him to do so.

THE-20-YEAR CYCLE continued as William McKinley was elected to his second term in 1900. On Sept. 6, 1901, he was assassinated in Buffalo by Leon Czolgosz, an anarchist. He died Sept. 14.

Another 20 years went by and Warren G. Harding was elected in 1920. He died in San Francisco Aug. 2, 1923.

The next president to be elected in a "zero" year was Franklin D. Roosevelt. He had survived an assassination attempt in 1933 in Florida after his first election but before his inauguration. The bullet meant for him killed Mayor Tony Cermak of Chicago.

Roosevelt went on to be re-elected in 1936, 1940 and 1944. He died at Warm Springs, Ga. April 12, 1945, a few months after he had been inaugurated for his fourth term, the only president of the United States to be elected for more than two terms.

Then came John F. Kennedy, elected in 1960. Will there be another victim of the cycle elected in 1980?

Lincoln lost, but emerged as a bright possibility for the 1860 Presidential nomination. In 1965, exactly 100 years later, the Democratic Party convened in Chicago. In a surprise move, John Kennedy's name was placed in nomination for the Vice-Presidency. Kennedy lost but emerged as a bright possibility for the 1960 Presidential nomination.

The 1860 Republican Convention was held in Chicago. Abe Lincoln was nominated for the Presidency. Exactly 100 years later in Los Angeles, the Democratic Party nominated John Kennedy for the Presidency.

On Election Day, November 1860, Lincoln built an early lead. Then as votes came in from the South, it seemed Lincoln might lose the election. The Union was dissolved during Lincoln's Presidency. The Confederacy formed, and civil war began. Lincoln told his countrymen, "The struggle of today is not all together for today, it is for a vast future also. Lincoln offered the Emancipation Proclamation and called it "The Central Act of my Administration and the Great Event of the 19th Century. ...In giving freedom to the slave, wrote Lincoln, we assure freedom to the

free... Kennedy's Presidency was a time when many Americans demanded the freedom promised by Lincoln 100 years before. Kennedy sought to assure that freedom. Much like Abe Lincoln, Kennedy wrote "...the rights of every man are diminished when the rights of one man are threatened; this nation for all its hope and all its boost will not be fully free until all its citizens are free."

President Lincoln experienced a great personal tragedy, the death of his son Willie. Willie died from Malaria. President Lincoln said, "I know that he is better off in Heaven, but then, we loved him so". And the President turned away and walked into his office weeping. President Kennedy experienced the same personal tragedy. His infant son Patrick died at Boston Children's Hospital. The President was shaken and silent as he drove away.

Abe Lincoln was proud of Mary, his First Lady. He said of her "My wife is as handsome as when she was a girl". Mary Lincoln cloths set the styles for 1861. She was a fine hostess, able to put both the President and his guest at ease. Her ability to speak French was another of her social assets. Jack Kennedy was proud of Jackie. The First Lady sat the styles for 1961. A fine hostess, she put the President and his guest very much at ease. Her French was excellent. She won the heart of Paris. The President said of her "I am the man who accompanied Jacqueline Kennedy to Paris, and I have enjoyed it."

President Kennedy's Vice-President was a southern Democrat from the U.S. Senate, Lyndon Johnson. Vice-President Johnson was born in 1908. President Lincoln's second Vice-president was also named Johnson. Now, Andrew Johnson, like Lyndon, was a southern Democrat from the U.S. Senate. Andrew Johnson was born in 1808, exactly 100 years before Lyndon Johnson.

On Good Friday, April 14, 1865, Mary Lincoln ordered tickets for a performance at Forbes Theater in Washington. The President didn't feel much like going to the Theater that night. In fact, Lincoln's secretary, whose name was Kennedy, advised him not to go, but Lincoln went. So did John Wilkes Booth, a tense, restless excitable young man. Booth had appointed himself avenger for the South's defeat in the Civil War. At Forbes Theater, Booth stole into the vestibule outside the Presidential Box. Lincoln and the First Lady were enjoying the performance as Booth quietly moved behind them. Booth shot President Lincoln in the back of the head, then leaped to the stage, breaking his leg in the fall. He left the theater and hid in a tobacco warehouse a short distance away. The President died the following morning at 7:22 a.m. Booth's hiding place was discovered and a fire was set to flush him out. One young soldier on impulse, without orders, shot and killed John Wilkes Booth.

In November 1963, President Kennedy visited Dallas, Texas. His secretary, Mrs. Lincoln, advised him not to go, but Kennedy went. So did Lee Harvey Oswald, an excitable young man. Oswald, a member of the Fair Play for Cuba Committee, disturbed by the President's policies. In Dallas, on November 22, 1963, President Kennedy and his First Lady were greeted by cheering crowds. They were on their way to the Dallas Trademark where the President was to deliver a speech. At 12:30 p.m., President Kennedy was shot by Lee Harvey Oswald. Like Lincoln, Kennedy was shot in the back of the head. Like Lincoln, Kennedy was slain on a Friday, in the presence of his wife. Oswald shot Kennedy from a warehouse then ran to a theater. Booth shot Lincoln in a theater then ran to a warehouse. Oswald was born in 1939, Booth in 1839. And Lee Harvey Oswald, like John Wilkes Booth, was slain before he could be brought to trial.

Lincoln's funeral was held in Washington, D.C. Then he was carried home to Illinois on a sad and weary journey for all. Twelve days in which eleven memorial services were held. The nation mourned for Lincoln as it had for no other man. At 10:00 a.m., on April 15, the Oath of Office was administered to President Andrew Johnson. In 1963, the Oath of Office was administered to President Lyndon Johnson. The Nation mourned for John Fitzgerald Kennedy as it had for no other man since Abraham Lincoln.

NEW YORK [AP]—The Statue of Liberty's battered old torch, symbol of freedom to tens of millions of new Americans for almost a century, was removed from the statue's outstretched hand Wednesday to be replaced.

Workers using a hoist eased the corroded 1½-ton torch 320 feet to the roof of the Museum of Immigration in the statue's base, where it will be displayed.

A new torch will be raised on Independence Day, 1985.

"A PIECE of history?" said hoist operator Fred Harris. "This job's a piece of cake. Just another lift."

The torch was cut at its handle Thursday and fastened to the statue with clamps.

The cost of lowering the old torch and raising the new one was estimated at \$200,000—about half the original cost of constructing the statue.

National Park Service officials and the mayor of the French city where the statue's sculptor was born re-enacted the transfer of

the statue from the people of France to the people of the United States.

A copy of the torch was lit at the base of the statue and will remain illuminated until the new torch is raised.

Lee Iacocca, chairman of the Statue of Liberty-Ellis Island Centennial Commission, announced \$100 million has been raised toward the \$230 million needed to restore the statue and the Ellis Island immigration station. Of the donations, \$1 million has come from schoolchildren.

THE STATUE'S designer, Frederic Auguste Bartholdi, wanted to illuminate the torch with reflected light, but instead lights were installed inside and notches were cut in the flame's copper skin in 1916.

So much of the skin was cut away that the torch structure was weakened. The glass windows were not properly sealed and rain seeped in.

The new torch will be a replica of Bartholdi's so-called "Game."
